Dear Mr. Stewart:

This is in response to your letter of June 20, 2003 to the Food and Drug Administration (FDA) pursuant to 21 U.S.C. 343(r)(6) (section 403(r)(6) of the Federal Food, Drug, and Cosmetic Act (the Act)). Your submissions state that Doctor's Brand, LP is making the following claim, among others, for the product Liquissentials ™ Joint Support Formula:

"There is significant human and animal research showing that these ingredients support joint care. For Example: McAlindon TE, LaValley MP, Gulin JP, Felson DT. Glucosamine and Chondroitin for Treatment of Osteo-arthritis A Systematic Quality Assessment and Meta-analysis. J Amer Med Assn (JAMA) 2000;283:1459-75."

In the preamble to the January 6, 2000 Final Rule on structure/function claims, FDA stated that placing a citation to a scientific reference that mentions a disease in the title on the immediate product label or packaging should be considered a disease claim for that product because of the unusual and unnecessary prominence of such a placement (see 65 FR 1000 at 1024). Further, we stated that for citations to scientific references that refer to a disease use in the title and that are included in other types of labeling, the agency would consider the context in which the citation is presented; one element that we stated we would look to is the prominence of the citation in the labeling. We stated that such use of a citation would not necessarily be an implied disease claim if, for example, it were not given prominence by the use of such devices as bolding, using large type size, or prominent placement (for example, the citation is simply listed in the bibliography section of the labeling among other titles). We believe that your use of the citation above (i.e., McAlindon et al.) is an implied disease claim that your product is intended for use in the treatment, prevention, mitigation, or cure of a disease (i.e., osteoarthritis). It is not one of a group of citations to articles that presents a balanced discussion of the totality of the available science about the product's ingredients; rather, it is a citation to a single review of some of the available information about studies of two of the three ingredients in your product and it is inserted conspicuously as an element of the claim itself. Therefore, the use of this citation in the manner you have used it in your promotional literature appears to be an implied disease claim under 21 CFR 101.93(g)(2)(iv)(C).

Page 2 - Mr. W. Paul Stewart

21 U.S.C. 343(r)(6) makes clear that a statement included in labeling under the authority of that section may not claim to diagnose, mitigate, treat, cure, or prevent a specific disease or class of diseases. The statement that you are making for this product suggests that it is intended to treat, prevent, or mitigate a disease. This claim does not meet the requirements of 21 U.S.C. 343(r)(6). This claim suggests that this product is intended for use as a drug within the meaning of 21 U.S.C. 321(g)(1)(B), and that it is subject to regulation under the drug provisions of the Act. If you intend to make claims of this nature, you should contact FDA's Center for Drug Evaluation and Research (CDER), Office of Compliance, HFD-310, Montrose Metro II, 11919 Rockville Pike, Rockville, Maryland 20852.




