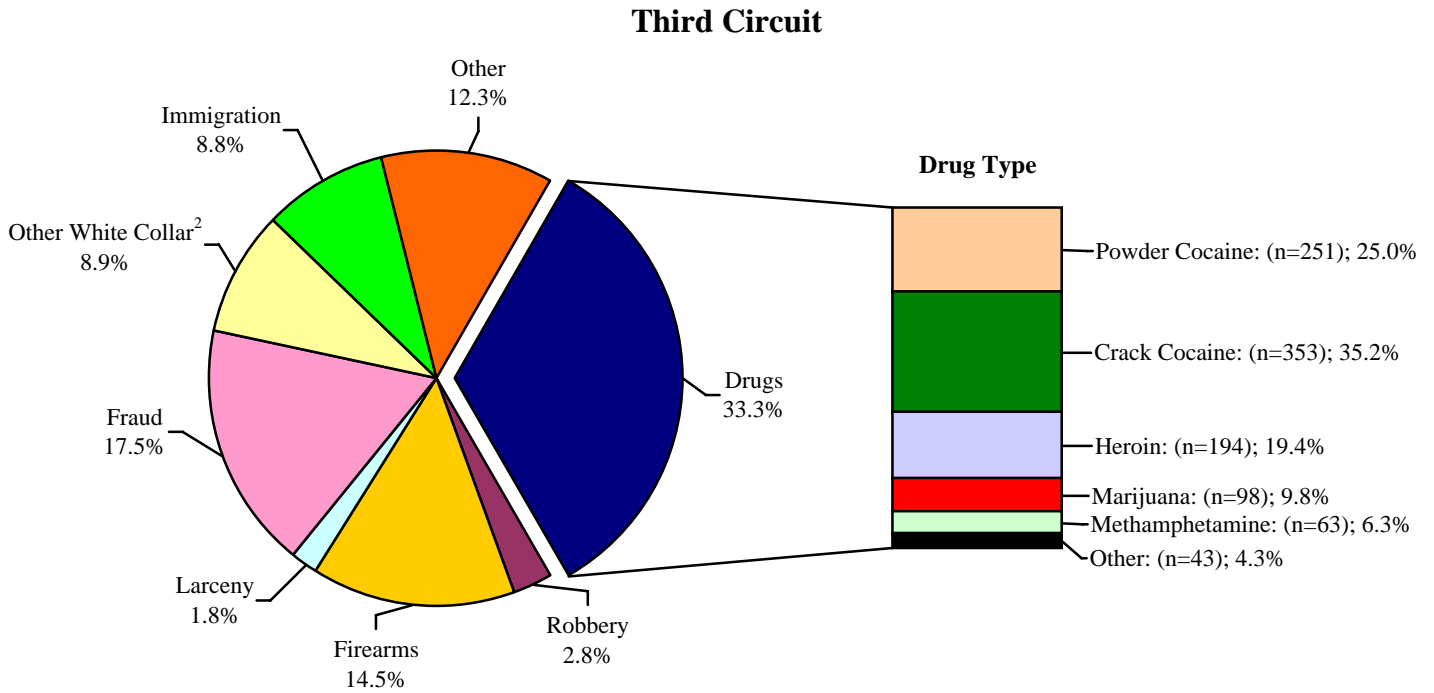
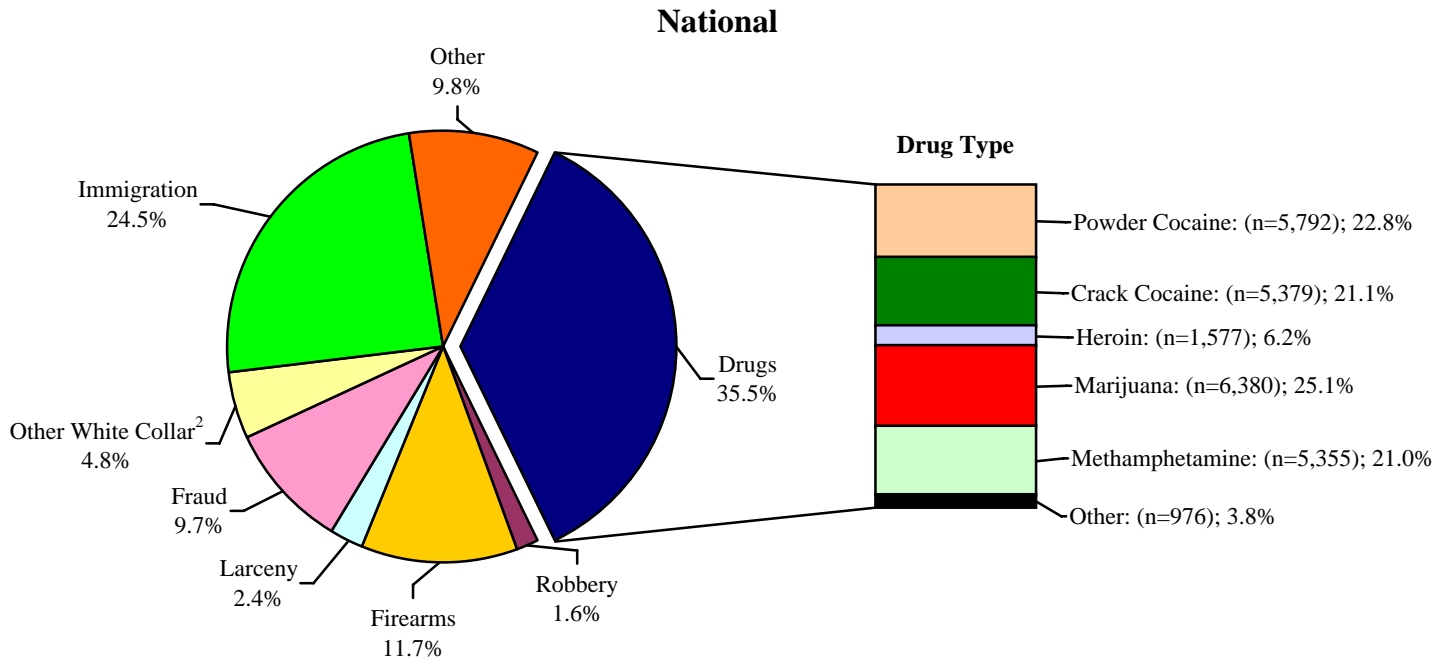

Of the 72,585 guideline cases, 9,622 cases were excluded for one or more of the following reasons: zero months prison ordered (8,871), missing primary offense category (67) or missing or indeterminable sentencing information (751).

Of the 3,016 guideline cases from the Third Circuit, 577 cases were excluded due to one or more of the following reasons: zero prison months ordered (551), missing primary offense category (1) or missing or indeterminable sentencing information (26).
