## **5-YEAR PROPOSED PROGRAM OF WORK:**

- Operate and maintain sites to standard within available revenue stream.
- Reduce deferred maintenance by 20% over the 5-year life of the Program of Work.
- Focus available resources on sites which conform most closely to the Forest Recreation Niche.
- Maintain and enhance customer satisfaction of available sites.
