SUBJECT: BEGINNING CHILD SUPPORT SPECIALIST AND ATTORNEY TRAINING
SEPTEMBER 23-27, 2002 – ATTORNEY SLOTS AVAILABLE

The Department of Child Support Services is soliciting attorneys to attend the upcoming Beginning Child Support Specialist and Attorney Training being held September 23-27, 2002 in Sacramento. Minimum Continuing Legal Education credits are pending with the California State Bar for this event.

At this juncture, the Child Support Specialist track is full, however, we are accepting names for a waiting list. There are still a number of vacancies for the attorney track.

As you recall from TC Letter: 02-11 (attached), the attorney track of this training replaces the prior Beginners Prosecutors College. This training is appropriate for attorneys that have not attended an FSO or Prosecutors College, and have at least three months on the job. DCSS Beginning Child Support Specialist and Attorney Training

This training replaces the prior Beginners Family Support Officer (FSO) College and the Beginners Prosecutors College to create a new combined beginners training event. This training will be broken out into two child support specialist tracks, and one attorney track.

This event is appropriate for child support staff who have not attended an FSO or Prosecutors College, and have at least three months on the job.

The opening plenary session will be designed to give all participants a consistent statewide overview of child support. Minimum Continuing Legal Education (MCLE) credit will be offered for the attorney track. Child Support Directors Association (CSDA) and California District Attorneys Association (CDAA) will assist in the planning of this event.



Morning and afternoon breaks will be provided daily. Lunches will be on your own.

Cancellation Policy:

Cancellations will not be accepted after September 6, 2002. After that date, registrants will be obligated to pay the full registration fee.

Location
