Request for Proposal (RFP) Title: MHSA Evaluation Phase 1: Scope of Work RFP Number: 08-78129-000

It is the opinion of the Department of Mental Health that the above mentioned solicitation is complete and without need of explanation. However, several questions have been asked and the Department of Mental Health has come to the decision to answer some of those questions. The questions and answers are as follows.

1. What is the expectation that stakeholders will be part of the Phase 1 process? Is the Department of Mental Health (DMH) looking for consumer input to the process? Will the Mental Health Services Oversight and Accountability Commission (MHSOAC) review deliverables prior to acceptance?

Stakeholders, including client and family members, will need to be a part of the Phase 1 process. Updates and progress reports will be provided to the MHSOAC throughout the Phase 1 process.

2. Will the DMH oversight staff for this project be located in Sacramento?

All MHSOAC staff are located at the MHSOAC office in Sacramento.

3. On page 6, concern is expressed regarding inspection of work sites. Does DMH anticipate that the contractor will operate distributed project offices for this effort?

4. In the scoring section, significant weight is given to large-scale projects. On which aspect(s) of scale will DMH place greater weight: size of budget, project duration, the number of stakeholders or the geographic scope?

5. On page 17, in Exhibit A, the grid in Section 4 lists State Agency representatives. Please confirm whether this section is intended for internal use by DMH.

6. Please clarify what the reviewers would like to see in Section 5. Results, deliverables versus Section 5. Timeline, progress reports.
