

Small Business Profile: IOWA

Small businesses are the heart of Iowa's economy. Research by the Office of Advocacy shows that small businesses create most of the nation's net new jobs, and they bring dynamic ideas, innovative services, and new products to the marketplace. They account for almost all of the nation's employer firms and generate half of non-farm private output. New business creation is key to a state's ability to increase its gross state product, state personal income, and total state employment.¹ This small business profile uses the most recent data available to demonstrate the valuable contributions that small businesses make to Iowa's economic health.

Number of Businesses. Iowa had an estimated total of 261,800 small businesses.² Employer firms totaled 71,400 in 2006, up 1.2 percent from the previous year. Of this total, an estimated 97.5 percent, or 69,600 were small. Self-employment (incorporated and unincorporated) totaled 209,000 in 2006, an increase from 207,700 in 2005. Non-employer firms totaled 192,900 in 2005, an increase of 2.1 percent since 2004. Women-owned Firms. In 2002, businesses owned by women numbered 63,800, represented 26.9 percent of the state's 236,500 businesses, and generated \$7.4 billion in revenues. Employer firms owned by women totaled 8,700, an increase of 5.3 percent since 1997. Women numbered 67,600 or 32.3 percent of the state's self-employed persons in 2006, a decrease of 5.5 percent from the previous year. Minority-owned Firms.³ In 2002, Asian-owned firms totaled 1,800, and 700 of them were employer firms; Black-owned firms numbered 1,600, and 200 were employer firms; Hispanic-owned firms totaled 1,500, and 400 were employer firms. American Indian and Alaska Native-owned businesses numbered 600; employer firm data for this group are not

available. Native Hawaiian and other Pacific Islander-owned businesses numbered 20, and fewer than 10 were employer firms. (Source: U.S. Dept. of Commerce, Census Bureau.)

Business Turnover. An estimated 5,877 new employer firms were created in 2006, which is 2.1 percent less than the number created in 2005. Business bankruptcies totaled 208 in 2006, down from 455 the previous year, while business terminations increased from 6,800 in 2005 to 7,200 in 2006. Employment. Small firms employed 53.2 percent of the state's non-farm private labor force in 2004, which was above the national average of 50.9 percent.⁴ These 64,200 firms accounted for 97.5 percent of the state's employer businesses, and they employed 660,400 people (Table 1). Small businesses added a total of 15,100 net new jobs between 2003 and 2004 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a share of small business income, increased by 4.7 percent, from \$6.4 billion in 2005 to \$6.7 billion in 2006.⁵ (Source: U.S. Dept. of Commerce.)

Finance. Commercial banks and savings institutions continued to be important sources of small business financing. The number of lending institution branches in the state increased in 2006 (Table 3).
