

## Florida

Florida's 1.9 million small businesses provide economic opportunities to diverse groups of people and bring innovative products and services to the marketplace.\* This profile from the Office of Advocacy compiles the latest facts and figures on the status and role of small business in the state. (Note that a small business is defined here as one with fewer than 500 employees.)

- Florida had 426,073 small employers in 2006, representing 99.0% of the state's employers and 44.0% of its private-sector employment.
- The construction industry was the state's largest small business employer in 2006; administrative and support and waste management and remediation services was the largest overall employer (Table 1).
- Small businesses created 58.7% of the state's net new jobs from 2004 to 2005 (Table 2).
- Florida's real gross state product had a negligible increase in 2007. By comparison, growth in the Southeast region was 1.5% and the United States, 2.0%. (Source: U.S. Dept. of Commerce: Bureau of Economic Analysis)
