

The Table of Contents is divided into six major subject categories: Employee Demographics; Compensation, Payroll, and Work Years; Performance Management Programs; the Senior Executive Service (SES); Retirement and Insurance Programs; and Student Employment Programs. Each table shows the source and a telephone number for easy direct access to the person in OPM responsible for that information.

Each year this report is issued as a helpful guide summarizing and compiling Federal employee statistics from the previous year. The 2003 edition of The Fact Book is primarily based on 2002 statistics and therefore does not present data or facts specific to the Department of Homeland Security (DHS) which was newly created in 2003. Similarly, statistics on the Transportation Security Administration, which became part of DHS in 2003, are, for this edition, included in the Department of Transportation. When issued, the 2004 edition of The Fact Book will include the appropriate statistics breakdowns for DHS.

THE FACT BOOK is produced annually by the U.S. Office of Personnel Management (OPM) as a convenient reference suitable for a variety of audiences. It contains descriptive statistical information, using tables and charts, about many aspects of the Executive Branch workforce. Note that data for the U.S. Postal Service are excluded from all tables except those on pages 8 and 64, and the tables in Part 4. Both historical and current data are displayed, resulting in a comprehensive snapshot of the Federal worker -- personal and professional characteristics, employment levels, and benefit payments and contributions. The statistical tables and charts in THE FACT BOOK are based on data from a wide range of sources, each of which is cited on the appropriate page with telephone contacts and email addresses if available.





The "Typical" Federal Civilian Employee, 2002










Retired Military Status






The "Typical" Federal Civilian Employee, 2002


Job Characteristics




Pay System




Average Adjusted Basic Salaries and Full-Time Employment by State




Average Adjusted Basic Salaries and Full-Time Employment by State







All Areas, Full-Time Only (1963 - 2002)






Executive Branch Employment 1986 - 2002



By Gender & Race/National Origin, 1996 - 2002







Employment of Women by Occupational Category














Quality Step Increases (QSI's)






Allocated vs Appointed






Presidential Rank Awards










Federal Employee Health Benefits Program Enrollment & Coverage


Enrollee Category












Retirement System On Annuity Roll at End of Fiscal Year






Operating Revenues and Expenses, Fiscal Year 2002












Participants' Educational Levels and Occupational Groups


