EXPERIMENTAL DISTILLED SPIRITS PLANT INFORMATION

As requested, we are enclosing the necessary forms in applying to set up an experimental distilled spirits plant. Please be sure to provide an Email address, when you submit your paperwork, for contact purposes. This will enable us to notify you when we receive your application and possibly process your paperwork more quickly. The following forms must be submitted to this office:

- 1. TTB F 5000.29, Environmental Information
- 2. TTB F 5000.30, Supplemental Information on Water Quality Considerations
- 3. TTB F 5110.56, Distilled Spirits Bond
- 4. TTB F 5000.9, Personnel Questionnaire, for the person responsible for the operations (SINGLE COPY)
- 5. TTB F 5000.8, Power of Attorney, if applicable

You must file a letterhead application and describe the following:

- In detail, the nature, extent, and purpose of your proposed operations
- The production operations and equipment you will be using
- The location of the plant (including the proximity to other premises or operations regulated by TTB)
- The security measures to be provided in connection with these operations
- An explanation of the expected length of time of the project

If you are filing as a sole owner and someone will be signing on your behalf, you must file TTB F 5000.8, Power of Attorney.

If the premises to be used for this operation are eligible for the National Register of Historic Places, you should not begin construction or remodeling until you have contacted the State Historic Preservation Officer (see enclosed information).

When your application is approved, you will be notified whether you need to file a bond and, if so, the amount of the penal sum.

Regulations prohibit you from conducting any experimental distilling operations in your home.
