Child Support Services Letter No. 01-13 informed Local Child Support Agencies (LCSAs) of a new procedure pertaining to Project Save Our Children (PSOC), a Federal Office of Child Support Enforcement (OCSE) initiative that addresses enforcement of child support obligations in interstate cases.
