SUBJECT: REFERABLE AND/OR RECOUPABLE AID CODES

This letter is to provide a comprehensive listing of all public assistance and Medi-Cal Aid Codes applicable to children that are referable to the child support program. The list was developed through the cooperative efforts of the Department of Child Support Services in conjunction with the Department of Health Services, and the Department of Social Services (DSS).

Prerequisites of whether an Aid Code is referable and/or recoupable are designated by program including; CalWORKs, Foster Care, and Medi-Cal. However, the list is not inclusive of all historical Aid Codes.

This index is to be used as a reference guide for the local child support agencies (LCSAs) to help determine if a referral received from their local DSS is appropriate and recoupable. Additionally, the list may be beneficial for the LCSA staff to identify cases that have been incorrectly referred.
