- 1 PROCEEDINGS
- 2 CHAIR ROGERS: We are going to call the Finance
- 3 Committee meeting to order. Finance Committee members: John
- 4 Erlenborn, Douglas Eakeley. Is LaVeeda here? No.
- 5 MR. MCKAY: But Edna --
- 6 CHAIR ROGERS: Is this an immediate effective
- 7 change?
- 8 MR. MCKAY: Yes.
- 9 CHAIR ROGERS: Edna Fairbanks-Williams is here. So
- 10 we also have committee -- or board members present, Tom
- 11 Smegal, Maria Luisa Mercado, Ernestine Watlington.
- 12 And I ask that we begin by a motion to approve the
- 13 agenda, which is on page 53 of the board materials.
- 14 MOTION
- MR. EAKELEY: So moved.
- 16 CHAIR ROGERS: Second?
- 17 MR. ERLENBORN: Second.
- 18 CHAIR ROGERS: All in favor?
- (Chorus of ayes.)
- 20 CHAIR ROGERS: Second, I'll ask for a motion to
- 21 approve the minutes of the meeting of January 26, 2001.

- 1 MOTION
- 2 MR. EAKELEY: So moved.
- 3 MR. ERLENBORN: Second.
- 4 CHAIR ROGERS: All in favor?
- 5 (Chorus of ayes.)
- 6 CHAIR ROGERS: Opposed?
- 7 (No response.)
- 8 CHAIR ROGERS: And David Richardson is here. And,
- 9 David, we'll ask that you take us through the review of the
- 10 consolidated operating budget expenses and other funds
- 11 available through April 30th.
- MR. RICHARDSON: Okay. For the record, my name is
- 13 David Richardson, and I am the Treasurer/Comptroller of the
- 14 Corporation.
- On page 60 of your board book, we have the
- 16 reporting for the seven-month period ending August 30. The
- 17 budget that was passed by this board was \$333,100,226, and
- 18 that was done in January. To date, we have spent a total of
- 19 \$317,041,751 through contracts with our field and with the
- 20 different administrative expenses.
- 21 The main areas that you see there, of course, is

- 1 your basic field funding. We still have some money remaining
- 2 there. We spent \$307.6 million -- and I will round from here
- 3 out, so we will be having all the numbers shown -- expressed
- 4 here.
- 5 But there is still an amount of \$1,665,000 that's
- 6 left for short-term funded or funding decisions that have not
- 7 been fully implemented for this year, but it is earmarked for
- 8 service to a particular area. So the money is obligated on
- 9 that basis.
- 10 The US Court of Veterans Appeals, we have given
- 11 awards there. There is a small amount of administrative
- 12 expenses that will be added to that. There will be a good
- 13 bit of that money left unless there is an additional award
- 14 given at the end of the year, and that money rolls over into
- 15 next year for grants for the US Court of Veterans Appeals.
- 16 Within the technology, there is an RFP that is in
- 17 the field. They're getting ready to review those
- 18 applications, and there should be a good deal of money spent
- 19 in the next three months. In regards to the technology, all
- 20 of that basically should be awarded for that program.
- 21 Within the corporate management administration, you

- 1 see that we have a total of \$7.2 million of that. Almost \$6
- 2 million is for management and \$1.2 million is for the IG.
- I won't go into a whole lot of detail there because
- 4 what we have is basically we've spent, per this particular
- 5 budget, 49.94 percent of the money in management and
- 6 administration through the first seven months. We should be
- 7 at about a 58.3 mark at this time, so we're well within
- 8 budget as far as the total money spent.
- 9 And within the Inspector General's Office, they
- 10 have spent 45.85 percent -- you'll find those percentages on
- 11 page 63 and 64 of your book -- and that gives you a breakout
- 12 as far as what we've spent as far as personnel compensation,
- 13 the benefits and each of the budget categories on a
- 14 percentage basis.
- 15 I don't call a whole lot of attention to that
- 16 because what we're getting ready to do now is we've submitted
- 17 a new budget plan. We have a new budget document that we'll
- 18 go over it as the next agenda item that reallocates the money
- 19 that we are not currently spending on salaries and other
- 20 items and reallocating them into areas that will be used in
- 21 the next six months.

- 1 So while there is no -- there's no action today.
- 2 These are simply reports. These are actions that are taken
- 3 under the authority of the president, but we bring this
- 4 report to you each quarter.
- 5 The one other item that I would call your attention
- 6 to is we did allocate \$325,000 of interest into this year's
- 7 budget, and through April we have collected \$199,000. So
- 8 we're on target to collect the amount of money needed to
- 9 underwrite what we've projected to help us with the
- 10 operations this year.
- 11 CHAIR ROGERS: Okay. Remember that the generation
- 12 of that interest is partly the result of your work, David,
- 13 for which we are very grateful.
- MR. RICHARDSON: Thank you.
- 15 CHAIR ROGERS: Are there questions about the budget
- 16 --
- MR. SMEGAL: And that interest comes from accrued
- 18 funds that we get from -- through the government and invest?
- 19
- MR. RICHARDSON: What we do, sir, is it's float.
- 21 When we write a check, we put the money in the bank. If it

- 1 takes two weeks for the check to be cashed, we earn the
- 2 interest on it.
- 3 MR. SMEGAL: Okay.
- 4 MR. RICHARDSON: And that's the same way as some of
- 5 the money, of course, is earned on the grants. We have to
- 6 put the money in the bank two days before we electronically
- 7 transfer the funds to the bank, so we get two days' interest
- 8 on that.
- 9 And approximately 85 percent of our grantees are on
- 10 electronic transfer. We still have a few that receive a
- 11 check, and of course we receive whatever interest on that
- 12 money until they get the check in the bank and it clears.
- 13 CHAIR ROGERS: Maria Luisa.
- MS. MERCADO: David, on I think it's page 66, your
- 15 column two on the budget revisions, are those the changes
- 16 that you've made where you reallocated to a different fund
- 17 line, in parentheses?
- 18 MR. RICHARDSON: That is correct.
- 19 MS. MERCADO: Those are the changes? And for
- 20 example, the 38,000 in the first line, where would that go?
- 21 Where would that be reallocated to?

- 1 MR. RICHARDSON: Okay, that's earmarked -- it goes
- 2 throughout the whole budget. We look at money that's not
- 3 being spent, and then we reallocate it. If I had to pinpoint
- 4 as to where the money went, I'd say to legal affairs at this
- 5 point because of the amount. You see that they received
- 6 260,000 additional funding for this final six months because
- 7 of the ongoing need for outside counsel.
- 8 MS. MERCADO: So the bulk of it went to program
- 9 performance and legal affairs, pretty much?
- 10 MR. RICHARDSON: That is correct. And I apologize.
- 11 There is a memo that has been put out and you evidently do
- 12 not have a copy, so we'll get that for you.
- MR. SMEGAL: Maria Luisa, the pluses and minuses
- 14 are about 400,000, and 260 and 115 -- or 113 -- are what you
- 15 pointed out.
- MS. MERCADO: Right.
- 17 MR. SMEGAL: The rest of it's 27,000.
- MS. MERCADO: Right. And I can see it because that
- 19 was my other question that I had. On page 62, on the
- 20 consulting line for legal affairs, and I assume that that's
- 21 for outside counsel?

- 1 MR. SMEGAL: David, do you --
- MS. MERCADO: No, I'm sorry.
- 3 MR. SMEGAL: David, do you have one more? I
- 4 managed to lose my copy. I'm sorry, there's one right there.
- 5 MS. MERCADO: I'm sorry, I was asking you a
- 6 question when you were still studying that.
- 7 MR. RICHARDSON: That's okay.
- 8 MS. MERCADO: On page 62, the budget line for legal
- 9 affairs, and I think that was my other question, and I think
- 10 you've probably answered that. On the consulting line, the
- 11 \$286,000 in consulting, that's for outside counsel; is that
- 12 correct?
- MR. RICHARDSON: That is correct.
- MS. MERCADO: Okay.
- 15 CHAIR ROGERS: David, on page 68, the \$1.3-
- 16 something million for consulting and management, what is that
- 17 for?
- MR. RICHARDSON: Okay. The main monies that we
- 19 spent consulting on -- there is consulting, basically, in
- 20 every budget. Your fees for attendance at a board meeting
- 21 are considered consulting fees. So that is one thing.

- 1 Additionally, we have consulting contracts dealing
- 2 with technical assistance to the field. We provide
- 3 competition review. We bring in people for a panel from
- 4 outside, from the field, to review those areas where there is
- 5 competition so that we have a field representative and inside
- 6 personnel reviewing those contracts to make recommendations
- 7 to the president.
- 8 Additionally to that, the bigger part this year is
- 9 over 400,000 -- almost 500,000 -- in outside counsel for the
- 10 ongoing litigation that we have.
- 11 CHAIR ROGERS: Would that be under legal affairs,
- or would that be under management budget?
- 13 MR. RICHARDSON: They are added together.
- 14 CHAIR ROGERS: Oh, so that's the total under
- 15 management budget?
- 16 MR. RICHARDSON: Right. When you look at page 68,
- 17 management budget, we are picking up the \$1.3 million. That
- 18 includes --
- 19 CHAIR ROGERS: I see, I see. That's the total of
- 20 the whole line across.
- 21 MR. RICHARDSON: That is correct.

- 1 CHAIR ROGERS: Okay.
- MS. MERCADO: Also, then adding the 1.3 and the
- 3 406,000 for the Inspector General equals the 1.79?
- 4 MR. RICHARDSON: That is correct.
- 5 MS. MERCADO: One more. So the program performance
- 6 -- then the contracts were outside -- consultants -- that's
- 7 the 553,000?
- 8 MR. RICHARDSON: That's a part of it. There's
- 9 other things that are ongoing that take effect there, but,
- 10 yes, that's a part of it..
- MS. BATTLE: What is the bulk of it for the program
- 12 performance aspect of those contracts?
- MR. RICHARDSON: Well, we have technical
- 14 assistance. We have state planning people coming in. We're
- 15 providing some technical assistance grants. We have the
- 16 client conference. There was some money for that. And
- 17 people brought in -- I see Randi is standing up. She may
- 18 want to get into a little more detail.
- 19 You're getting ready to have the technology
- 20 program. There's money set aside for the consultants from
- 21 the field and technical experts to come in and review those

- 1 technology proposals so that they can then come forward with
- 2 a recommendation to the president for grants. There's a
- 3 whole array of things in there.
- 4 Randi, would you like to --
- 5 MS. YOUELLS: (Off mike.) The Office of Program
- 6 Performance uses consultants for three or four main
- 7 functions. One, of course, is grants review, both in terms
- 8 of the normal competition and in terms of the technology
- 9 grants, where we bring in the review panels. After the staff
- 10 has made some initial determinations we have the (inaudible)
- 11 that take a second look before those recommendations come to
- 12 me and to the president. So that's a good chunk of it.
- 13 Also, a good chunk of it this year is technical
- 14 assistance on the basis of state planning, where we hire
- 15 consultants. States or programs ask us for dollars to hire
- 16 merger consultants, to hire people to help them run meetings
- 17 in which they are discussing certain aspects of state
- 18 planning.
- We recently, just last week, granted \$10,000 to the
- 20 California project directors to do a statewide retreat about
- 21 some aspects of state planning. So those types of dollars

- 1 will be allocated out to the field.
- 2 And then periodically we use consultants on staff
- 3 for state planning to support the work of the staff because
- 4 we have had -- we have small staff working on it. Joe
- 5 Daling, the Executive Director from Prairie State Legal
- 6 Services, Chuck Cook, the Assistant Director of the Ohio
- 7 Legal Assistance Foundation, are both on consultant
- 8 contracts, and they work with states on state planning and
- 9 they replace the work of a staff.
- 10 So it would be generally in those primary areas.
- 11 Of course, technology grant review is a big chunk of it this
- 12 time.
- 13 CHAIR ROGERS: Thank you, Randi. Maria Luisa?
- MS. MERCADO: No, I was just wondering whether --
- in the information technology you have \$112,000 in consulting
- 16 fees, so when you're talking about the technical assistance
- 17 that our vice president was just talking about, is that
- 18 different from the information technology consulting?
- 19 MR. RICHARDSON: Yes, it is. What she is referring
- 20 to is the technology grants and the technology that they
- 21 coordinate with the field, and we have technology

- 1 professionals on staff that work with the field.
- 2 And, of course, then we have the \$7 million this
- 3 year in grant awards. So we are staffing and hiring some
- 4 consultants to review those proposals.
- 5 MS. MERCADO: Okay.
- 6 MR. RICHARDSON: The technologies, since you do
- 7 mention that, that's another large amount, is for the
- 8 security of our network system. A few months back when there
- 9 was some spam that put out, or different breaking-in of the
- 10 different Pentagon computers and so forth -- well, ours was
- 11 one that was hit also. So we've now put in some security
- 12 firewalls. There were some firewalls there; we're now
- 13 updating them.
- And, of course, we receive transmissions back and
- 15 forth from the field all the time. This is helping to give
- 16 secure websites so that we can protect the information that
- 17 we do receive from the field.
- 18 CHAIR ROGERS: Are there questions or comments?
- 19 MS. FAIRBANKS-WILLIAMS: No, I was just wondering,
- 20 the human resources one there was kind of different. Have
- 21 you accounted for anybody as leaving besides John McKay? Is

- 1 there anybody leaving, or do you have those packages all
- 2 under control?
- 3 MR. RICHARDSON: They are not in this submission
- 4 here. We will be talking with John Erlenborn next week in
- 5 regards to those.
- 6 MS. FAIRBANKS-WILLIAMS: So you are saying you have
- 7 some things left over in human resources and personnel
- 8 compensation and so on, but you haven't worked that extra
- 9 money into there?
- 10 MR. RICHARDSON: The agreements have not been
- 11 finalized.
- MS. FAIRBANKS-WILLIAMS: Okay.
- 13 MR. RICHARDSON: So, as a result, I don't know the
- 14 figures to work in at this point.
- 15 CHAIR ROGERS: I think we have been talking about
- 16 four as well, but are there any additional comments or
- 17 questions about the projected operating expenses for Fiscal
- 18 Year 2001?
- 19 MS. FAIRBANKS-WILLIAMS: The other question that I
- 20 have -- I don't know which number it comes in under -- was
- 21 the communication seems to be high through April. I realize

- 1 that it's technology.
- Is it going to continue to climb for the rest of
- 3 the year, or do you think it's leveled out?
- 4 MR. RICHARDSON: We hope it has leveled out;
- 5 however, we have increased the technology line as a result of
- 6 this budget revision. It was underestimated at the prior
- 7 year.
- 8 Actually, there was a situation where the
- 9 communications was being handled by two different offices and
- 10 there was just not enough money budgeted for it, so we are
- 11 now remedying that with this budget revision.
- 12 CHAIR ROGERS: And the answer to the question of
- 13 whether technology is within communications was yes, or --
- MR. RICHARDSON: It is not.
- 15 CHAIR ROGERS: It is not.
- 16 MR. RICHARDSON: No. No, within the communications
- 17 line we have mailing, telephone, those type of costs --
- 18 overnight express mailings that we do. But then when you
- 19 look at the technology, that's for the computer consultants
- 20 that we're using, and that actually comes under the
- 21 consulting line. So it's not communications.

- 1 MS. MERCADO: And is the reason that the bulk of
- 2 the communications budget is out of the office of financial
- 3 and administrative because you're really the one that's
- 4 responsible for that? I mean, it has \$103,000 compared to
- 5 other offices that are between \$2,000 and \$7,000.
- 6 MR. RICHARDSON: Right. The communications -- all
- 7 the long-distance telephones and the telephone service -- is
- 8 funded out of the administrative offices, yes.
- 9 CHAIR ROGERS: Five is, Consider an act on the
- 10 President's recommendations for consolidated operating budget
- 11 allocations.
- David, is that page 68?
- MR. RICHARDSON: It is 68.
- 14 CHAIR ROGERS: Attachment B?
- MR. RICHARDSON: That is correct. So we have the
- 16 consolidated operating budget, which does show a net of zero
- 17 as far as no increase in the budget. It's been reallocated
- 18 to the different areas. And then 68 is the breakout within
- 19 the budget category.
- When the agenda was originally written, we
- 21 contemplated that there may be some board action needed.

- 1 Because of the nature of the changes we have made, it's
- 2 simply a report; there's no requirement for the board to
- 3 adopt a separate budget because it's still the same total
- 4 that we had before.
- 5 And the same thing with the -- actually the next
- 6 item, I think, is the COB reallocations. There are no COB
- 7 reallocations. That would be money that would have been
- 8 coming in from interest over and above the 325,000 that would
- 9 be allocated back to the budget, or if there was grant
- 10 recoveries that came in that's being reallocated back to the
- 11 budget. We do not have those at this point.
- 12 CHAIR ROGERS: So although the agenda says
- 13 "Consider and act," you're saying, David, we don't need to
- 14 act?
- MR. RICHARDSON: That is correct.
- 16 CHAIR ROGERS: Okay. Any further discussion on
- 17 six, which is the internal budgetary adjustments that were
- 18 made by the president and the Inspector General?
- 19 MR. SMEGAL: I have a question, and it may overlap
- 20 several categories.
- David, I've forgotten, in my absence from the

- 1 finance committee, the carryovers from the prior year, where
- 2 are they shown on page 60?
- 3 MR. RICHARDSON: They are not. What I've done is
- 4 I've shown the appropriation, and then the carryover to come
- 5 to a revised budget. So you've got the January approved
- 6 budget --
- 7 MR. SMEGAL: Right.
- 8 MR. RICHARDSON: And when you look at the 333
- 9 million and we've got an appropriation of 329 million. So
- 10 the carryover is --
- 11 MR. SMEGAL: -- is in that number?
- 12 MR. RICHARDSON: -- is in that number.
- 13 MR. SMEGAL: Somehow it's gotten in there, okay.
- 14 Without putting it in a category such as A, one to four, or
- 15 A, one to ten, under corporate management. Okay, it's
- 16 somehow allocated but not separately allocated as a carryover
- 17 item.
- 18 MR. RICHARDSON: That's correct.
- 19 CHAIR ROGERS: Maria Luisa?
- 20 MS. MERCADO: Yes. In the carryovers that we show,
- 21 both on page 67 and I guess on page 60 -- I'm sorry, on page

- 1 61 -- define carryovers. Those go back into the management
- 2 and administration line? They don't go back to the field
- 3 budget, do they?
- 4 MR. RICHARDSON: That is correct. Well, let me
- 5 back up. The grant recoveries that you see there, we do
- 6 allocate that to the grants from other funds available. So
- 7 we normally fund special emergency grants or special
- 8 situation grants.
- 9 Not funded in April, but in May, there was a
- 10 situation of a fire with a grantee in New Mexico, and we
- 11 awarded \$27,000 out of that line to help them recover from
- 12 the fire.
- 13 CHAIR ROGERS: So it goes back to the field, but
- 14 through management decisions on grants?
- 15 MR. RICHARDSON: That's correct.
- 16 CHAIR ROGERS: Any other questions or discussions?
- 17 (No response.)
- 18 CHAIR ROGERS: I think we are on item seven, which
- 19 is report on LSC's budgetary needs for Fiscal Year 2003.
- 20 MR. RICHARDSON: Okay. This is sort of a heads-up
- 21 type of report. At the September meeting, we will need to

- 1 either adopt a budget for Fiscal Year 2003 or a budget mark
- 2 so that we can go to Congress by the October 15th deadline,
- 3 or we'll need to have some discussions and then a telephonic
- 4 meeting to set that mark.
- 5 I've talked with Don Saunders, and his group will
- 6 be coming forth with the budget mark from NLADA. I have not
- 7 talked to other members, representatives from the ABA or
- 8 anyone else, but if they have a budget mark that they would
- 9 like to submit to us, we would be glad to look at their
- 10 information.
- And then if any of the board members would like to
- 12 submit a budget, we will review those, we will present them
- 13 to the board, but then we'll come forward and ask the board,
- 14 either at the September meeting or at the telephonic meeting,
- 15 to adopt a budget mark.
- So this is sort of a heads-up that that will happen
- in September.
- 18 CHAIR ROGERS: Any discussion of that? Questions,
- 19 comments on the budget mark?
- 20 MR. RICHARDSON: If I can add further, there has
- 21 been some different things that have been discussed here

- 1 yesterday; for instance, the program of retiring debt for
- 2 attorneys. And that's something that we looked at a year ago
- 3 and considered putting in the budget, but it was taken out
- 4 later.
- 5 Those are the type of things that we're looking at,
- 6 if there are programs who have initiatives that they'd like
- 7 to see us undertake. We have talked about a nationwide
- 8 retirement plan. We also talked about a nationwide or at
- 9 least some type of legal needs assessment.
- 10 So those are the type of things that we're looking
- 11 to add to the budget to see if we would like to go to
- 12 Congress and ask to see if we'd like to have them funded and
- 13 at what level. So it's a matter of starting to develop plans
- 14 to work in the future for us.
- MS. MERCADO: Right, and I think we had also talked
- 16 about nationwide technology that was all compatible with all
- 17 the different programs in the national, if in fact the data
- 18 gathering and everything that you need to do is much easier.
- 19 MR. RICHARDSON: Mm-hmm.
- 20 CHAIR ROGERS: So solicitation of views and
- 21 thoughts on such things as law school loan forgiveness,

- 1 retirement?
- 2 MR. RICHARDSON: Yes.
- 3 CHAIR ROGERS: What were the last two?
- 4 MR. RICHARDSON: The loan forgiveness -- we were
- 5 thinking about a legal needs assessment. And health programs
- 6 -- we were told there are at least a few, if not many, of our
- 7 programs who don't offer full health care.
- 8 So if there's any of those type of initiatives out
- 9 there that there's a need, we'd like to hear about them to
- 10 see if there's anything that we can do to address them.
- 11 CHAIR ROGERS: This is the consider and act on
- 12 other business portion of our committee meeting.
- 13 Is there any other business?
- 14 (No response.)
- 15 CHAIR ROGERS: If not, thank you, David. That was
- 16 very clear and helpful, and it looks like things are on a
- 17 sound footing.
- 18 Is there a motion to adjourn?
- 19 MOTION
- MR. ERLENBORN: So moved.
- MS. FAIRBANKS-WILLIAMS: Second.
