SUBJECT: QUALITY ASSURANCE BRANCH LCSA ASSIGNMENTS

This letter is to inform you that Quality Assurance Branch (QAB) staff at the Department of Child Support Services have been given specific local child support agency (LCSA) assignments as part of workload restructuring. With the completion of the transition process and the 2002 compliance reviews, attention will turn to plans for implementing the Quality Assurance and Program Improvement (QAPI) project. As an integral part of this effort, analyst staff in QAB are each assigned specific LCSAs, for which they have total oversight responsibility. This will give the LCSAs the advantage of one contact person at the state level for all aspects of QAPI.

Attached is a list of the LCSAs and the assigned analysts, including their telephone numbers and electronic mail addresses. These assignments are effective July 1, 2002. Your assigned analyst, in coordination with your regional administrator, will contact you to arrange a meeting to provide an orientation for you and those of your staff involved in QAPI. You will also receive information soon regarding the development and submittal of a county QAPI plan.
