SUBJECT: STATE FISCAL YEAR 2007/08 BUDGET DISPLAY AND STATE FISCAL YEAR 2008/09 BUDGET PROCESS

The purpose of this letter is to provide local child support agencies (LCSAs) with instructions and information to aid in the completion of the State Fiscal Year (SFY) 2007/08 Budget Display (CS 921). The Budget Display is a budgeting tool to gather information for use in the development of the SFY 2008/09 Non-Electronic Data Processing (Non-EDP) Administrative Initial Planning Allocation. The completed Budget Display must be submitted to the Department of Child Support Services (DCSS) by close of business February 8, 2008. This will enable DCSS to release the Non-EDP Administrative Initial Planning Allocation in February 2008 based on the proposed Governor's Budget for SFY 2008/09. LCSAs will receive the EDP Maintenance and Operations (M&O) Budget Request for SFY 2008/09 in a separate mailing.

The SFY 2007/08 Budget Display is intended to gather detailed data to reflect how LCSAs utilized their SFY 2007/08 Non-EDP Administrative Final Allocation. In addition, it allows the LCSAs to reconcile their approved local budgets to the DCSS allocation. Finally, it provides an early opportunity for LCSAs to report additional needs anticipated in SFY 2008/09.

It is important to re-emphasize several key points that have been made in prior allocation letters in regard to the current budget situation. First, all LCSA Directors are reminded that current year expenditures must be carefully monitored to ensure that final allocation amounts are not exceeded. Local agency expenditure patterns that exceed the amount allocated must be immediately adjusted to remain within the amount allocated. DCSS is not obligated to reimburse costs that exceed the LCSAs authorized allocation.

Section K, Additional Needs for SFY 2008/09 of the Budget Display provides LCSAs the opportunity to report any additional funding needs anticipated in SFY 2008/09. Requests must be clearly identified to denote adjustments (positive and negative) to the SFY 2007/08 Non-EDP Administrative Final Allocation and specify whether those needs can be funded within the current allocation or require new funding. In addition, it allows LCSAs to indicate necessary budget reductions should new funding not be available.

In order to report information on the Budget Display, LCSAs will access the document on the website. As in previous years, LCSAs **are not required** to submit a hard copy of the Budget Display to DCSS. Once the Budget Display is ready to be submitted to DCSS, the LCSA IV-D Director must click on the approve button, which appears on the last page of the Budget Display. The Budget Display is considered submitted once it has been approved by the LCSA IV-D Director.

In order to meet the February allocation deadline, the completed Budget Display must be finalized on the website by February 8, 2008. The Budget Display will be available on the DCSS website on January 4, 2008. Once the Budget Display is ready to be submitted to DCSS, the LCSA Director must click on the approve button, which appears on the last page of the Budget Display. The Budget Display is considered submitted once it has been approved by the LCSA Director.

NOTE:

- All Sections - to save the page after entering data, either click on the save page button at the bottom of the page or click on another section of the CS 921.
- Section K - a summary of the total from the Section K Worksheet is displayed on the Section K main page.
