The United States District Court for the Northern District of Ohio hereby indefinitely suspends the attorneys listed in Attachment A from practicing before this Court.

The attorneys listed in Attachment A were among the 13,000 attorneys suspended by Order of the Supreme Court of Ohio on December 2, 2005 for failure to pay registration fees. Local Rule 83.5 and Local Criminal Rule 57.5 require that attorneys be admitted to practice in the highest Court in their state in order to practice in this Court. Pursuant to General Order 2005-17, issued on December 5, 2005, this Court delayed taking immediate action in order to avoid inconvenience to this Court, and to minimize the risk that someone who remained eligible to continue practicing before this Court may have been misidentified as no longer being eligible and to afford the suspended attorneys with the opportunity pay the outstanding fees and provide this Court with official notification that they had been reinstated by the Supreme Court of Ohio. Pursuant to General Order 2006-01, issued on February 6, 2006, the attorneys suspended by the Supreme Court of Ohio were ordered to show cause on or before March 3, 2006 why this Court should not impose similar discipline. While many attorneys took the opportunity to become reinstated to the Supreme Court of Ohio, the attorneys listed in Attachment A have not and are hereby suspended pursuant to Local Rule 83.5 and Local Criminal Rule 57.7.

The names of the attorneys listed in Attachment A shall be stricken from the roll of attorneys admitted to practice law before the United States District Court for the Northern District of Ohio.

Readmission to practice before this Court requires the filing of an application for reinstatement with Geri M. Smith, Clerk of Court, Carl B. Stokes U.S. Court House, 801 West Superior Avenue, Cleveland, Ohio 44113-1830, ATTN: Committee on Complaints and Policy Compliance. The application should include evidence that the attorney is in good standing in the highest court of any state, territory, the District of Columbia or in any district court of the United States.

Upon receipt of the application, the Clerk shall refer the application to the Committee on Complaints and Policy Compliance, which shall schedule a hearing. At the hearing, the attorney shall have the burden of demonstrating by clear and convincing evidence that he/she has the moral qualifications, competency and learning in the law required for admission to practice law before this Court and that his/her resumption of the practice of law will not be detrimental to the integrity and standing of the bar or to the administration of justice, or subversive of the public interest. Should the Court find the attorney is found unfit to resume practice before this Court, the application shall be dismissed. No application for reinstatement shall be filed within one year following an adverse judgment upon an application for reinstatement filed by or on behalf of the same attorney.

If the attorney is found fit to resume practice before this Court, the judgment shall reinstate him/her, provided that, if the attorney has been suspended for two years or more, reinstatement is conditioned upon the attendance of the attorney at a Federal Court Practice Seminar. A copy of the Certificate of Training for successfully completing the Federal Court Practice Seminar should accompany the application for reinstatement. Registration in the Court's CM/ECF system will also be required.


If the attorney has been suspended for five years or more, reinstatement may also be conditioned upon furnishing proof of competency and learning in the law, which proof may include certification by the bar examiners of a state or other jurisdiction of the attorney's successful completion of an examination for admission to practice subsequent to the date of suspension.

All attorneys admitted to practice in this Court are required to submit a written notice of a change of business address and/or email address to the Clerk upon a change in address pursuant to Local Rule 83.5. Service shall be deemed made on the

attorney by sending this order, and all other orders in this case, by regular U.S. Mail or Federal Express to the most recent address the attorney has given to the Clerk of Court.
