The United States District Court for the Northern District of Ohio is now in receipt of an order from the Supreme Court of Ohio dated December 3, 2007, of its action suspending the following attorneys from the practice of law in the State of Ohio. Pursuant to this Court's Local Civil Rule 83.7(f) and Local Criminal Rule 57.7(f), you are hereby ordered to show cause why the identical discipline by this Court would be unwarranted and the reasons therefor.

Unless the Court determines otherwise, the Court's typical practice is to impose an indefinite suspension, with the ability to seek readmission to this Court upon reinstatement in the Court which imposed the original discipline.

Should you desire to appear before the Committee on Complaints and Policy Compliance on Monday, January 14, 2008, at 2:30 p.m., to show cause why you should not be similarly disciplined, please notify me, through Deputy Clerk Kerry Murphy at 216-357-7068, **on or before January 3, 2008**. Failure to respond will be considered a waiver of your right to show cause. The Court encourages counsel to correct their deficiencies with the Supreme Court of Ohio so as to not unnecessarily further inconvenience your clients and the Court and to notify Deputy Clerk Kerry Murphy as soon as possible.
