This table displays the total UPB by program as of the end of each fiscal year. Since data are not available through the end of the most recent fiscal year, the data displayed in 2009 are as of 03/31/2009.

UPB is defined as the end-of-year outstanding principal balance of loans that have not yet been charged off as of the end of the given fiscal year.

The data include the UPB of all active performing loans, delinquent loans, purchased loans, and loans in liquidation.

For guarantied loans, UPB is comprised of the SBA guarantied portion and non-guarantied portion of the loan.

Guarantied Business, Direct Business, and Disaster loan programs include all loans that are subject to the Credit Reform Act of 1990; which are loans SBA approved on or after 10/01/1991.

Pre-1992 loans include all Guarantied Business, Direct Business, and Disaster loans that SBA approved prior to 10/01/1991.

The 7(a) and 504 loans in the DELTA and STAR programs are included in the 'All Other' category, not the '7(a) Regular' and '504 Regular' categories, of guarantied business programs.
