SUBJECT: CHILD SUPPORT PROGRAM – REPAYMENT SHARING RATIOS FOR
 FEDERAL FISCAL YEAR 2002

This is to provide you with the new repayment sharing ratios for the Federal Medical Assistance Percentages for Federal Fiscal Year (FFY) 2002. The rates are to be used in determining the federal, State and county shares of child support collections on the CS 800 Reconciliation and Worksheet (CS 802) and for completion of the Child/ Family and Spousal Support Payments – Assistance Related Distribution/Disbursement Summary Report (CS 800).

These percentages will be effective October 1, 2001, through September 30, 2002. The federal sharing ratios will increase from the FFY 2001 rate of 51.25% to 51.40% for FFY 2002. The new repayment ratios are as follows:

Child Support collections received to recoup aid paid under the Emergency Assistance (EA) aid programs (06 and 43 aid categories) should be processed under the CalWORKs All Families, Federal category.

In addition, two new non-federal aid codes have been added to reflect necessary aid code changes for the CalWORKs cases in which the adult(s) has received TANF-funded assistance for a cumulative total of 60 months. These aid codes and their definitions are as follows:

Aid Code 32 – TANF Timed-Out: The head of household or spouse of the head of household (parent, stepparent, or caretaker relative) has received Federal TANF assistance for a total of 60 cumulative months and continues to be eligible for CalWORKs assistance.

Aid Code 3W – TANF Timed-Out, Mixed Case: The head of household or spouse of the head of household (parent, aided stepparent, or caretaker relative) has received Federal TANF assistance for a total of 60 cumulative months, continues to be eligible for CalWORKs assistance, and the family includes at least one non-federally eligible individual (other than the TANF timed-out individual).
