SUBJECT: COMPROMISE OF ASSIGNED ARREARAGES – REVISED FEDERAL  
 POVERTY LEVEL GUIDELINES

REFERENCE: CSS LETTER 03-05

This notice is to provide you with additional information related to CSS Letter 03-05 regarding the revised Federal Poverty Level (FPL) Guidelines used to compute income levels when determining eligibility for a compromise of arrearages. In the tables enclosed with the letter it was not clear how to determine the income levels for a family unit that exceeds 8 members. This is to clarify that for each additional person beyond 8 members on the chart for 250%, the FPL would increase by \$7850; for each additional person on the chart for 300%, the FPL would increase by \$9420. Revised charts are enclosed.
