SUBJECT: CSS LETTER 06-37 ERRATA

The purpose of this letter is to make two amendments to the information provided in CSS 06-37, dated October 11, 2006.

1. The All County Letter (ACL) 06-45 contained information unique to only IV-A reporting requirements for the Department of Social Services and was incorrectly copied into CSS 06-37. ACL 06-45 states:

~~**Remaining two-parent codes have not been changed.** Aid Codes 3M and 3U will continue to be claimed as State only cases. Changes to the claiming instructions will be provided to counties in a forthcoming DSS County Fiscal Letter.~~

The above statement was incorrectly copied to the DCSS CSS Letter 06-37, paragraph 1, on page 2. The revised statement regarding Aid Codes is corrected to read as follows:

Remaining two-parent codes have not been changed. Aid Code 3U Two-Parent Families (Mixed Cases) continue in DCSS under the Federal aid category. Aid Code 3M Legal Immigrant – Two-Parent Families remains in aid category, Non-Federal.

2. A misprint caused an error in the reporting requirements for Aid Code 35. CSS Letter 06-37 incorrectly states that former assistance cases are to be reported on the CS 34, Line 7a, Column A. Aid Code 35 must be reported on CS 34, Line 7a, Column C, (for former assistance cases).
