### Office of New Reactors (NRO) Items of Interest Week Ending April 27, 2007

### NRO Staff visit V.C Summer and Bellefonte Sites as Part of Pre-Combined License Application Activities

During the week of April 16, 2007, NRO and the Office of Nuclear Security and Incident Response (NSIR) staff visited two sites for which the NRC expects to receive combined license applications in Fall 2007 (V.C. Summer and Bellefonte). The purpose of the visits was to familiarize the staff with the proposed sites and to begin establishing working relationships with the applicants and local agencies. Topics discussed during the visits included hydrology, meteorology, ecology, radiation protection, socioeconomics, energy alternatives, and alternative sites. These visits are part of the pre-combined license application activities planned by the staff for all sites.

### General Electric (GE) Submits Integrated Schedule

On April 19, 2007, GE submitted an integrated schedule for deliverables associated with the design certification review of the Economic Simplified Boiling Water Reactor. Some key deliverables include Revisions 4 and 5 of the Design Control Document, Revision 2 of the probabilistic risk assessment, topical report submittals and revisions to topical reports. On March 12, 2007, GE submitted a rebaselined schedule for responses to requests for additional information. After consideration of this information, the staff will establish a schedule for future review milestones.

Second Round of Requests for Additional Information (RAIs) submitted related to Vogtle Early Site Permit Application

On April 20, the staff submitted a second round of RAIs to Southern Nuclear Company concerning the Environmental Report for the Plant Vogtle Site Early Site Permit. The letter also stated that there would be an impact to the schedule for the Draft Environmental Impact Statement (EIS) and the Final EIS.

## Office of Nuclear Material Safety and Safeguards (NMSS) Items of Interest Week Ending April 27, 2007

Ongoing International Atomic Energy Agency Safety Evaluation During Operation Evaluation at Brazilian Fuel Processing Facility

On April 25, 2007, a staff member who is participating in the first international Safety Evaluation During Operation (SEDO) mission of the International Atomic Energy Agency (IAEA), reported on the status of the mission. The SEDO mission is taking place at the Indústrias Nucleares do Brasil fuel processing facility in Brazil, and its purpose is to evaluate facility operations to identify findings that will assist the operator in its safety operations. The international team completed training on how to conduct the evaluation April 20-22, 2007, and arrived on site to initiate the evaluation on April 23, 2007. The team has been exceptionally well-received by the facility. In addition, the Chairman of the company participated in the opening of the evaluation. The evaluation will conclude on May 11, 2007.

#### Public Meeting With Energy Solutions on a New Transportation Package

On April 18, 2007, staff met with representatives from Energy Solutions to discuss the design of a new Type (B) package. The package will be used to transport irradiated hardware and contaminated dewatered powdered, dispersible solids, such as resins. Energy Solutions presented its design and stated that it is evaluating its design by analyses only (without performing any physical tests). The staff expressed reservations about developing impact loads based on analytically developed load-deflection curves, without performing any physical tests of the foam impact limiters. Energy Solutions stated that it is benchmarking its computer code, for the impact limiters, using previous drop tests for other cask designs. Energy Solutions plans to submit the application in July 2007.

<u>Public Meeting between NRC and External Stakeholders Regarding Risk-Informing 10 CFR 50,</u> Appendix G and 10 CFR 50.61 - Fracture Toughness Requirements

During the subject public meeting held on April 17, 2007, staff and industry researchers shared results of on-going programs investigating the technical basis for revision of 10 CFR Part 50 Appendix G and 10 CFR 50.61. The NRC research project being conducted at Oak Ridge National Laboratory and the industry research efforts are complementary. Since 10 CFR 50 Appendix G incorporates Appendix G of SC XI of the American Society of Mechanical Engineers code, by reference, NRC and industry researchers will jointly brief the appropriate ASME SC XI committees and working groups on research results.

#### List of Approved Spent Fuel Storage Casks: HI-STORM 100 Revision 3 (AH98 - Part 72)

On April 26, 2007, the NRC published a final rule in the *Federal Register* (72 FR 20713) that amends the entry for the HI-STORM 100 cask system in the list of approved spent fuel storage casks (Amendment 3) (AH98 - Part 72). This action eliminates cooling of the multi-purpose canister before flooding with water as part of cask unloading operations, allows linear interpolation between minimal soluble boron concentrations for certain fuel enrichments, and modifies several definitions. The final rule becomes effective May 29, 2007.

#### Government Services Administration (GSA) Federal Supply Schedule Requirement

As a result of a competitive GSA Federal Supply Schedule requirement, a labor-hour delivery order was awarded to Battelle Memorial Institute of Columbus, Ohio on April 19, 2007. This delivery order requires the contractor to provide technical assistance for "Evaluation of Leak-Before-Break Criteria." The period of performance is three (3) years and the total value of the delivery order is \$813,042.00.
