Dear Mr. Pardee:

On February 11, 2009, the NRC staff completed its performance review of Byron Station, Units 1 and 2. Our technical staff reviewed performance indicators (PIs) for the most recent quarter and inspection results for the period from January 1 through December 31, 2008. The purpose of this letter is to inform you of our assessment of your safety performance during this period and our plans for future inspections at your facility.

This performance review and enclosed inspection plan do not include security information. A separate letter designated and marked as "Official Use Only--Security Information" will include the security cornerstone review and resultant inspection plan.

Overall, Byron Station, Units 1 and 2, operated in a manner that preserved public health and safety and fully met all cornerstone objectives. Plant performance for the most recent quarter at Byron Units 1 and 2 were within the Regulatory Response column of the NRC's Action Matrix, based on one inspection finding of low to moderate safety significance (White) within the Initiating Events cornerstone related to the degradation of the Essential Service Water Risers.

Shortly after the end of the 2008 assessment period, the NRC completed a supplemental inspection to review the actions taken to address the White finding. Since there was no finding of significance identified during the inspection, the White finding will be removed from consideration in the Action Matrix in the second quarter of 2009. In addition, the inspection finding regarding the inadvertent entry into an elevated risk condition for Byron Unit 2 in April 2008, which was discussed in the 2008 Mid-Cycle Performance Review letter dated September 2, 2008, was determined to be a licensee identified finding of very low safety significance (Green).

In the Mid-Cycle Performance Review letter, we also advised you of a substantive cross-cutting issue in the area of human performance. The substantive cross-cutting issue was the result of several findings that involved deficiencies in human performance throughout the station. In response to the identified cross-cutting issues, you provided us your Human Performance Improvement Plan and specific actions that you planned to take to correct the cross-cutting issue performance deficiencies.

Nevertheless, the staff has continued to identify issues with a cross-cutting theme of decision making in the aspect of H.1(b). There were 17 documented findings of very low (Green) and low to moderate (White) safety significance as well as a SL-IV violation with cross-cutting aspect in the area of Human Performance. Five of these findings in the Human Performance area shared the common cross-cutting aspect of failure to make conservative assumptions and demonstrating the proposed action is safe (H.1(b)). These findings were from more than one cornerstone (Mitigating Systems and Initiating Events). Moreover, your Human Performance Improvement Plan actions have not yet proven effective in substantially mitigating the cross-cutting theme. Therefore, this substantive cross-cutting issue will remain open until the NRC gains confidence in the effectiveness of your human performance corrective actions.

Due to the continuing problem in this area, please provide us a written response regarding the progress that was made to improve the human performance at Byron Station and also please provide a status update to us during the annual End-of-Cycle Public Meeting to be scheduled later.

Please provide your response within 30 days of the date of this annual assessment letter to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001, with a copy to Richard A. Skokowski, U.S. Nuclear Regulatory Commission - Region III, 2443 Warrenville Road, Suite 210, Lisle, IL 60532-4352; and the Resident Inspector Office at the Byron Station.

The enclosed inspection plan details the inspections, less those related to security scheduled through June 30, 2010. Please note that we plan on conducting two infrequently performed IPs: IP 60854.1, "Preoperational Testing of an Independent Spent Fuel Storage Facility Installations at Operating Plants," and IP 60855.1, "Operation of an Independent Spent Fuel Storage Installation at Operating Plants," this year at your Byron Station. The inspection plan is provided to allow for the resolution of any scheduling conflicts and personnel availability issues well in advance of our inspectors' arrival onsite. Routine resident inspections are not listed due to their ongoing and continuous nature. The inspections in the last 9 months of the inspection plan are tentative and may be revised at the mid-cycle review.
