#### Call to Order: CDR Nita Sood ((NSood@HRSA.GOV)

CDR Sood called the May 2007 Pharmacist Professional Advisory Committee (PharmPAC) meeting to order.

#### **CPO Comments: RADM Robert Pittman**

#### ♦ IHS Southwest Regional Pharmacist Conference

- o Attended last week in Scottsdale, AZ
- Met with approximately 200 IHS pharmacists (including commissioned corps, civil service, and tribal pharmacists), pharmacy technicians, and retired pharmacists
- O Two awards were presented as follows:
  - IHS Junior Pharmacist of the Year LCDR Allison Painter, Shiprock, NM
  - IHS Senior Pharmacist of the Year CAPT Daniel Diggins, Jr., Phoenix, AZ

#### **♦** Transformation

- ORC-Macro group met this morning to discuss recruitment issues
- o RADM Pittman distributed copies of the new recruitment brochures
- o PHS website (<u>www.usphs.gov</u>) is under construction
- Advertising started the first week of April
- o The 800# is receiving approximately 134 calls per day
- PACs have been asked to look at how they can change the look and feel of their websites to correspond to the new PHS website; ORC-Macro has developed a template that all categories will be expected to use

#### **♦** Promotions

- Pharmacy category promotion board met in early April; prepared rank order list
- o Promotion rates are not known at this time; expected to be released in June
- O Regular Corps has a ceiling of 2800 officers, which is fast approaching (approximately 300 slots remain); this may affect success rates for permanent promotions and assimilations

#### **♦** Readiness

- Assessment was done at the end of April
- Multiple e-mails were sent urging officers to check their status on the OFRD website and to contact OFRD if they believe an error was made

#### **♦ COA Conference**

- ASH signed a memo indicating that 250 officers can be paid for by HHS operating divisions to attend the conference

- Does not affect officers who want to attend on their own or officers who are granted leave to attend

- o Used the physician PAC CAD packet as a template
- o 14 page document; quite comprehensive
- Will be distributed to new CADs as we get the list of names and will also be posted on the website
- o There was some discussion regarding the following issues:
  - Suggestion to utilize information from the JOAG welcome document
  - Suggestion to utilize information from the commissioned officers handbook, if it is still available (may be outdated)
  - Recommendation to include information on all PHS and pharmacist listservs
  - Question as to whether this document should be produced by OCCO since the information represents the entire Corps
  - Suggestion to send to new officers within 30 days of their CAD

- CDC.gov homepage has been revised; consolidated topic areas into 8 categories; new search engine; more comprehensive A-Z list of topics; CDC for you – customized content based on user profiles
- H5N1 update
  - New outbreaks among poultry; control measures have been instituted
  - Cases among humans contact with sick or dead poultry
- Emergency response exercises
  - Pandemic flu exercise 23 confirmed cases with 4 confirmed deaths
  - Hurricane tabletop exercise simulated category 5 hurricane to hit gulf coast
- ♦ Indian Health Service (IHS)→CDR Bradley Bishop
  - No report
- ♦ National Institutes of Health (NIH) CDR Sood for CDR Richard DeCederfelt
  - Continue to work on development of inpatient pharmacy information system to interface with existing computerized physician order entry system; estimated completion date is end of 2007
  - Construction of new facility to house all non-dispensing functions; estimated completion date is Summer 2008
  - Pharmacotherapy Frontiers forum was a success, approximately 325 pharmacists attended
  - Search committee has been formed to find a new pharmacy chief

  - There is a pharmacist vacancy in Alameda, CA; fills approximately 200 prescriptions per day; if interested contact CAPT Mary Fong or LCDR Romero
- ♦ Health Resources and Services Administration (HRSA) LCDR Jeff Mouakket
  - There are 2 openings for PAC membership for 2007-2010 term
  - o Division of Immigration Health Services has openings all over the country

  - o FDA approved a new vaccine for H5N1; will not be available commercially

  - o Dangers of buying prescription drugs over the internet
  - o FDA working with the National Library of Medicine to maintain a repository of drug labeling (NLM webpage daily med)

  - o Nothing new to report
