CPO Comments: RADM Robert Pittman

♦ Promotions

- o Congratulations to officers who received permanent promotions
- CPO Board met with promotion officers in OCCO
- o If you are up for promotion, please include a recent CV in your eOPF
- O CV summary page needs to be limited to 1-2 pages (depending on the category); pharmacy category currently recommends 1 page highlight the most important information
- o Promotion boards will receive guidance document from the CPO Board on how to rank officers with a low score (recommend vs. not recommend for promotion)
- Almost 30 senior pharmacist officers have volunteered to serve as career counselors; will
 provide training in mid-August; officers may request this service; in addition, officers in
 the bottom quartile (as assessed by the boards) will be required to receive career
 counseling

♦ Transformation

- o Sample billets are in beta testing; phase 3 is expected to begin shortly; expect to get the billets out at the beginning of the calendar year

Emergency Preparedness

In an effort to streamline emergency response before it is needed, CMS has announced the formation of the Emergency Prescription Assistance Program (EPAP). According to CMS, its partner Argus Health Systems will begin building a network of pharmacies and the program will work similarly to third-party insurance providing pharmacists with specific instructions on how to handle prescriptions for victims of disasters. Upon activation of the EPAP system by FEMA, disaster victims will be able to go to participating pharmacies to obtain new prescriptions, replace maintenance drugs, and obtain certain covered durable medical devices. The program follows closely on the heels of the development of www.icerx.org, a similar emergency preparation program

- As a point of clarification, the CV template did not change. We edited the content to make sure that it matches the 2008 benchmarks.
- There was discussion regarding the length of the CV summary page; pharmacy category currently recommends a 1 page limit. Senior officers may need additional space to

provide a positive portrayal of their record. It was emphasized that the CV template is a guideline for the pharmacy category. Officers should use their professional judgment along with the template to assess what best represents their record to the promotion board.
