• Minutes from the 05 Jun 2008 PharmPAC meeting were accepted with no edits via motion from CDR Josephine Lyght with a second from CDR Beth Fabian-Fritsch

#### Presentation of Awards/Certificates: LCDR Violette Ganoe (vganoe@bop.gov)

• PharmPAC Managerial Excellence Award – CAPT Nita Sood

#### <u>CPO Report</u> → RADM Robert Pittman

- COER Redesign
  - Prototype due from Lewin group Aug 1 for review
  - o Lewin group met with CPO Board and SG Board for discussion of COER draft
- Billets
  - o OCCO continues work on billets
  - o Release expected late 2008 or early 2009
- Website Transition of PACs
  - Mandatory to meet new HHS requirements
  - Facing difficulty in transitioning pdf files
- Permanent Grade Promotions

- o RADM Pittman congratulated those promoted
- Approximately 1,500 officers were eligible for promotion; 571 were promoted
- Only 85 officers were removed from promotion consideration for administrative reasons
- Low promotion rate to permanent O4 reflective of the Commissioned Corps approaching the 2,800 regular corps ceiling
- Attempts are being made to have Congress increase the ceiling above 2,800
- o Release expected late 2008 or early 2009

#### • Involuntary Retirement/Separation Board

- Meeting this August for first time in three years
- Expect to see board meet more often, primarily for officers that do not meet readiness requirements

#### Readiness

- Pharmacy category has dropped below 80%
- Our category is now the second from the bottom
- One potential cause is that many new officers have reached the end of their one year grace period and may have a missing readiness component

#### • Officer Personal Immunization Information

• Please note that your personal immunization information has to be recorded in two locations: your OFRD profile and sent to the Medical Affairs Branch (MAB)

#### • Loan Repayment

- o IHS has allocated \$3.3 million for pharmacists loan repayment
- This is \$650,000 more than last year
- o 85 awards have been given thus far (37 extensions and 48 new applications)

#### • Pharmacy Accession Bonus

- Consideration is being made into dividing the \$30,000 bonus into two \$15,000 payments one payment upon accession and one payment at the two year mark.
- o Advantages:
  - Financially easier impact on awarding agency
  - Better tax situation for recipient
  - Officer has ability to move to a new location after two years and new agency can provide second \$15,000 payment – currently an agency has the latitude to hold officer for four years because they can't get money from the receiving agency – money is not controlled centrally like DOD agencies
  - If officer chooses to leave the Commissioned Corps after two years, the officer will not owe a payback
- o Disadvantages:
  - Potential to adversely hurt recruitment
- Much discussion ensued on advantages and disadvantages of dividing the bonus with no decisive judgment on whether or not this would ultimately be a good decision for the commissioned corps, particularly as it relates to recruiting
- CAPT Bresette proposed a survey be sent to pharmacy students via the student listserv
- o LCDR Ganoe proposed a survey of recent call to active duty (CAD) officers
- CDR Shiber proposed a survey of the current applicant list
- It was noted that OMB has rules restricting our ability to survey non-government employees (pharmacy students and applicants)
- RADM Pittman asked CAPT Bresette to have a workgroup developed to put together a survey for recent CADs

    - Has published the first field book on cultural competency
    - Nov 3-6 (for prior service pharmacists) Combined Forces Pharmacy Seminar meeting in Louisville, KY – on-line registration opens today
  - American Society of Consultant Pharmacists (ASCP)
    - For Maryland pharmacists the Mid-Atlantic Conference will be Aug 7-10
  - American Society of Health System Pharmacists (ASHP)
    - Working with HRSA to change regulatory language that blocks pharmacists from getting paid for rural health activities if HRSA is not convinced to change the language, ASHP will lobby Congress to get this language changed
    - CFC albuterol inhalers will only be available for seven more months as a result of the Clean Air Act
  - American Public Health Association (APHA)
    - Published an article showing that a significant portion (over 22%) of the U.S. population is sharing medication

- Working to determine if different criteria should be defined for PharmPAC representation from each agency
- Letter has been sent to the Surgeon General requesting action be taken to have the membership ceiling raised above 20
- Within the current ceiling of 20 members, the workgroup is developing a new formula for determining the membership from each agency and will propose the new formula to the PharmPAC membership, perhaps as soon as next month's meeting.
- The workgroup queried two other large categories, Medical and Dental, but they didn't have an issue to the membership ceiling
- This issue will also be addressed at the August PAC Chair's meeting
- AMSUS
  - Annual meeting to be held Nov 9-14 in San Antonio
  - PHS is the sponsoring agency this year
  - o LCDR Diem Ngo is in charge of pharmacy category program at the meeting
  - There have been six PHS officers nominated for the AMSUS Award for Excellence in Clinical Pharmacy Practice and for the Andrew Craigie Award

- CDR Hobbs, CDR Addison, and ENS Burns have a listing of those pharmacists officers who are dual qualified UPOCs and ARs. Of the 130 ARs currently posted to the PharmPAC website at <u>http://www.hhs.gov/pharmacy/ar.xls</u> we have 74 officers who are both ARs and UPOCs. We are exceeding our Section benchmark to have at least 50% of the ARs as UPOCs and it will be reflected in our Section 2008 Annual Report
- UPOC FAQ document has been updated and formatting issues have been cleaned up. Will be re-posted to the recruitment page website in the next week.
- "Welcome to USPHS Handout" has been updated and will be updated to reflect USAA Career Starter Loan (a 2% interest loan). Will be re-posted to the recruitment page website in the next week.

#### • Student Programs Update – LCDR Christine Oliver

- Commissioned Corps Pharmacy Mentoring Network (CCPMN) CAPT Lillie Golson
  - Second annual training for mentors will occur sometime at the end of August or in September – this training will be more of an exchange and Q&A session between mentors instead of a didactic format
- Publishing Workgroup CDR Louis Flowers
  - Based on the advice of the reviewers of the Journal of the American Pharmacists Association's staff analysis, the Journal of the American Pharmacists Association would like to pursue publication of the PharmPAC Publishing Workgroup's article in the Commentary subsection of the Science and Practice section. The title of the article is "U.S. Public Health Service Commissioned Corps Pharmacists: Making a Difference in Advancing the Nation's Health." This decision to pursue publication is contingent on revising the paper as suggested by the reviewers. CDR Flowers has submitted the revised paper and is awaiting JAPhA's final decision.

  - Glitch with OFRD for officers switching from President's Challenge to the Annual Physical Fitness Test (APFT) – glitch has been corrected and will be reflective next quarter
- E-mails have been sent to those not qualified response has been good

- o 344 responses received
- High percentage of responders reflected the following:

- Not able to attend due to work schedule

- Don't know how the PharmPAC representation is determined

- LCDR Ganoe stated that the PharmPAC will continue to analyze and discuss the results of this survey and will consider changes in the PharmPAC operations based on this information
