• 2008 Recruitment Section Annual Report Overview - CDR Peter Vermilyea

- o 1,000 pharmacist officers on active duty reached September 10, 2008
- o \$15,000 retention special pay (RSP) for pharmacists activated in February 2008
- Results showed that most of the newly activated pharmacists would still prefer the accession bonus in the one-time, up-front \$30,000 payment
- o Website www.phspharmacist.org was overhauled to improve functionality
- University Point of Contact (UPOC) issued 2 newsletters this year and pharmacists are able to log-in their recruiting events on the website
- 36 excellence in public health pharmacy practice awards were presented by UPOC volunteers
- o Pharmacy's-Best-Kept-Secret and the new officer's welcome letter were updated
- o Student programs and social functions have increased student's awareness of the Corps
- Associate Recruiter Program (ARP) has 95 AR in the pharmacy category the ARP sent recruiting material to 32 events this year The ARP held a 2 day training in Rockville, MD and a morning seminar after the COF Symposium in Tucson, AZ this year
- Inactive Reserve Corps is moving ahead and had 12 pharmacy activations this year

- CDR Garvey summarized the mission of the PharmPAC
- CDR Garvey's 1st goal for the year is to increase meeting attendance
 - o Committed to streamlining the meetings and keeping them to 90 minutes in duration
 - o Meetings will be from 1300 to 1430 EST so more people are able to participate
 - o Elimination of oral roll call for guests will make the meetings more productive
 - o PharmPAC Assessment Survey of 348 pharmacists (1/3 of pharmacy category) revealed a strong preference for shorter PharmPAC meetings
 - Working group will be formed to further review the PharmPAC Assessment Survey results
- CDR Garvey's 2nd goal for the year is to encourage more open discussion at the meetings
 - o Section leads are to focus updates on activities that have significant changes and on activities that require the PAC's attention
 - o Allow for more open discussion at the end of the meetings
- CDR Garvey's 3rd goal for the year is to increase the transparency of the PharmPAC
 - The PharmPAC is asked to review draft policy documents from the Office of the Surgeon General
 - o CCMIS website identifies the documents under review
 - o The PharmPAC will share the broad concept of the documents under review and share their responses that are forwarded to the Surgeon General

Old/New Business:

- New Business Working group will be formed to review the PharmPAC Assessment Survey CDR Patricia Garvey
 - o CDR Garvey will send an email requesting volunteers to participate in the working group
 - CDR Garvey will create a working group that is balanced and has an assortment of agencies represented

- New Business RADM Pittman tasked the PharmPAC to form a working group to look into establishing a pharmacy school at USUHS – CDR Patricia Garvey
 - CDR Garvey will send an email requesting volunteers to participate in the working group
 - CDR Ed Stein will lead the working group
- New Business APhA annual meeting CDR Patricia Garvey
 - Meeting is scheduled for April 3-6, 2009 in San Antonio, TX
 - 2 delegates and 2 alternatives will be selected as representatives more information to follow
 - CDR Ed Stein also mentioned that 3 volunteers will also be needed to act as official patients for the student national pharmacy counseling competition

 - 15 pharmacist applications in October
 - 8 calls to duty in October
 - o Pharmacist category has reached 1,000
 - IHS, FDA, and BOP continue to be the 3 largest agencies with pharmacist officers
