Locate an FDIC-insured institution, both active and inactive. – Search <u>Bank Find</u> for your bank to find out if it is insured; find the locations of your bank's branches; find out if your bank has merged or been acquired; or review your bank's history.

Examine your bank's financial data – View any bank Call Report (Call) or Thrift Financial Report (TFR) filed since 1998.

View the industry's overall picture – See the latest quarterly <u>Statistics at a Glance</u> (Current Snapshot) that define the banking industry and the most recent trends (Industry Trends).

**Identify the latest performance trends in your state** – Obtain detailed State Banking *Performance Summary* (<u>QBP State</u> <u>Tables</u>) by any state (annual and quarterly data for large and small institutions go back to 1995).

- Financial and demographic data, quarterly and year-to-date income, condition and performance ratios; quarterly and annual data go back to 1992
- Compare performance and condition data between individual institutions, between individual institutions and groups, and between different groups.
- Groups can be constructed by state, size, charter, holding company and other attributes.
