Note 1: Application for a permit and payment of proper fees must be made prior to or upon commencement of work or the fee will be doubled in accordance with Section 106.5.1 of the International Mechanical Code. **Application must be signed and dated by the contractor doing the work.**

Note 2: The "requested inspection" fee is \$45.00, provided that such service is not in excess of 1 hour in duration. \$25.00 for each 30 minutes or fractional part thereof in excess of 1 hour plus travel and per diem.
