FORWARD

This report has been prepared in response to a September 10, 2003, letter from the Office of Management and Budget (OMB) and the Office of the Federal Environmental Executive (OFEE) to Federal Agency Environmental Executives and Agency Senior Procurement Officials. This letter transmitted a survey for reporting on agency purchases of recycled-content products pursuant to Resource Conservation and Recovery Act, Section 6002 and Executive Order 13101, *Greening the Government through Waste Prevention, Recycling, and Federal Acquisition.*

Responsive to the OMB/OFEE letter, this report contains the following:

- an Executive Summary;
- a table summarizing the Department of Energy's (DOE) Fiscal Year 2003 purchases of Environmental Protection Agency-designated recovered content products (i.e., products containing recycled materials); and
- a completed survey on DOE purchases in Fiscal Year 2003, and access to supplemental information on environmentally preferable purchasing and solid waste recycling.

EXECUTIVE SUMMARY

- This report summarizes the Department of Energy (DOE) Fiscal Year (FY) 2003 purchases of Environmental Protection Agency (EPA)-designated products that were obtained from non-Federal sources. DOE purchases from Federal sources of supply, such as the General Services Administration, Government Printing Office, and the Defense Logistics Agency are reported separately by those agencies.
- In FY 2003, DOE purchased products with recovered content (i.e., containing recycled materials) in 50 of the 54 items on the EPA-designated products list. Table 1 summarizes DOE purchases of EPA-designated products with recovered content for FY 2003. The purchase data are summarized in two ways:
 - Purchases of EPA-designated items containing recycled materials are compared to total purchases of these items. This yields percentages that reflect the overall effect of DOE purchasing on the "recovered content" marketplace.
 - A comparison of purchase data adjusted for allowable exceptions authorized by Federal Acquisition Regulation 23.405(c), where EPA-designated recovered content items could not be purchased due to cost, performance, or availability. This yields percentages that reflect the overall performance of the Department's Affirmative Procurement Program (also referred to as Environmentally Preferable Purchasing).
- DOE's procurement of items on EPA's designated products list specified recycled content 79% of the time. In a number of cases, virgin-content products were purchased instead due to product availability, cost viability, and product performance considerations. As a result, 72% of all DOE purchases of EPA-designated products contained recycled material (see Table 1).
- The Department's purchasing power continues to play an important role in DOE's commitment to environmental sustainability and waste prevention. In FY 2003, DOE purchases exceeded \$26 million for environmentally preferable products containing recycled material. Over the same period, the Department also recycled half (50%) of the solid wastes (non-radioactive/non-hazardous) generated at its production, analytical, and research and development activities across the country.

DOE assessed the data quarterly to determine whether there were 1) misunderstandings regarding the data elements, 2) shortfalls in compliance with the requirements of the Executive Order, or 3) shortfalls in reporting. Generally, the data analysis indicates that DOE contracting activities and management contractors were in compliance with Environmentally Preferable Purchasing (EPP) provisions. FPDS data was reviewed by designated Green Acquisition Advocates at DOE field sites who have had to correct some erroneous data, but Contract Specialists who input the data have gained a better understanding of what was required over the year and were alert to including EPP specifications in service contracts in which the

- contractor provides products with recycled content. However, as reflected in the numbers reported above, FPDS data is only collected for direct Federal purchases above \$25,000, and typically the management contractors who operate DOE sites acquire the bulk of the products designated by EPA.
- Please describe findings, changes, and/or actions that were a direct result of the assessments or analyses above. DOE contract specialists are alert to the program and its data elements. The Green Acquisition Advocates and Procurement Data Coordinators again provided supplemental training in 2003 regarding the program and its data requirements. In addition, the Department holds quarterly EO 13101 teleconferences for its Recycling Coordinators and Green Acquisition Advocates to discuss and share experiences EPP implementation, monitoring and reporting.

Commercial Sanitary Tissue Products

Industrial wipes are required to be lint-free, anti-static, and non-abrasive (i.e., non-recycled material content) for cleaning optics.

In some situations, non-recycled materials are required in order to meet "clean room" requirements.

Industrial wipes were required to be lint-free for the job specified and were not available with recycled-content paper.

Special purpose (coated) sanitary tissue paper, and heavy duty (reinforced) paper tissues were unavailable with the recycled content.

Commercial sanitary tissues with recycled content were not available due to time constraints.

Not able to determine whether or not product contained recycled content. Further investigation of products needed.

Special lint-free wipes are required for scientific experiments to avoid contamination.

Most of the sanitary tissue products contain recycled content. However, some of the higher quality products are only available as virgin products.

End users were not willing to pay the increased cost of recycled tissue. Others wanted a specific type that was not available in recycled. Cost was below the competitive threshold and it was determined further search would not be cost effective.

Toner Cartridges

Toner cartridges without recycled content were purchased due to time constraints. Toner cartridges with recycled content were only available at a higher price. Toner cartridges without recycled content were purchased due to performance requirements for technical manuals.

There is a cultural resistance in using remanufactured toner cartridges. Users believe that by using remanufactured toner cartridges they will not only damage their copiers, but also are told, by the manufacturers that it could void their warranties.

Remanufactured toner is not available at this time for color copy machine.

Utilization of non-standard and state-of-the-art equipment prevents complete acquisition of recycled toner cartridges.

Current toner cartridge supplier does not have the capability to remanufacture recently released or many color toner cartridges with the necessary performance requirements at a reasonable price.

These cartridges were not available as remanufactured: Epson, 790, OCE plotter, Xerox 2135 and Xerox 1235. Xerox does not recommend use of a remanufactured cartridge for some of the specified equipment. Most recently, Xerox remanufactured 1235 and 2135 are now available to be tested.

Purchased toner cartridges for many different brands of fax machines, photocopiers, and color laser printers that require unique cartridge casings-available only from the original manufacturer.

Manufacturer requires non-recycled cartridges to maintain equipment warranty.

New printers and copiers were added to the facility during FY03 and a source of supply for remanufactured cartridges for a few printers had not been established. Most have now been established.

Recycled toner cartridges are not available for a limited number of newer black and white laser printers and were unavailable for most color printers. The depleted cartridges for all printers and reproduction machines are shipped for future refurbishment and recycling. Price, availability, and short delivery-time were advantages for purchasing items with virgin materials.

Contract set up with a small local supplier to refill all cartridges that can be refilled. Some of the printers were so new there were no empty cartridges available to refill.

For some color printers remanufactured cartridges are not available or have poor quality features.

Re-refined Oil

When performing maintenance on equipment that is designated as critical, the original maintenance standards must be followed preventing the substitutions on virgin materials.

The item made with recovered materials is not available within the performance requirements.

No known local source for 5W20 re-refined oil. Hydraulic oil (grade 46 and viscosity of #32) was not available as re-refined that met the equipment specifications. Warranty on the Ford vehicle specifies 5W20 which is not available locally as re-refined.

Lubricating oil is purchased in bulk. Recycled or re-refined lubricating oil is not readily (locally) available in bulk quantities.

The oil purchased with required specific grades and viscosity-weight, were unavailable, or unavailable in the quantities needed, with re-refined content. In another instance, using re-refined oil would void the engine warranty on the heavy equipment.

Some re-refined lubricating oil for vehicle maintenance was only available at a higher price.

Site terrain calls for unique types of equipment which must use non-recovered oil. Tested 10W30 re-refined oils determined that the re-refined oils break down under extreme heat conditions. The majority of the fleet vehicles are not driven under normal driving conditions. Vehicles are driven an average 2-3 miles with excessive idle speed that causes the oil to heat up and break down.

Motor oils were required for unique engine applications and these were not readily available with recycled content.

Not all types of oils/products were available in required schedules, or not available in accordance with the required specifications.

Signage

Specified sign with royal blue tint was not available with recycled materials. Aerial marking signs which could be viewed at the specified distance were not available with recycle-content.

The signs purchased were special ordered to meet specific site requirements. The manufacturer would not guarantee the printed end product if the signs were constructed with recycled content plastic material.

Specific items were not available as recycled content products and price considerations were also included as exceptions to purchasing recycled content products.

Signage required specialty materials made out of components other than those listed in EPA's CPGs.

Special signs are required for general safety, laboratory doors, street safety, and dangerous situations--often with reflective, self-adhesive materials that were not readily available with recycled content.

Sheet metal used for signage is not tracked as separate entity as they are fabricated on-site out of bulk material.

Site supplier for name plates and badges does not carry recycled plastic. Costs are below competitive threshold and it was determined a search for a new supplier would not be cost effective.
