Field Office Implementation Workshop Regarding Title 10,
Code of Federal Regulations, Part 851

The Department of Energy (DOE) contractors must submit their written worker safety and health program that meets the requirements of title 10, Code of Federal Regulations, part 851 (10 CFR 851), by February 26, 2007. The Office of Health and Safety, the Office of Enforcement (both within the Office of Health, Safety and Security), and the Office of the General Counsel have continued their interactions with DOE Federal and contractor staff and the Energy Facility Contractors Group to make the implementation of the Worker Safety and Health Program Rule as smooth as possible.

Through the use of workshops, teleconferences, videoconferences, and personal calls, we have been able to determine the major concerns of both the contractor and Federal community. This input was used to develop guidance materials and tools to assist in the implementation process. This information was then made available on our 10 CFR 851 Web site. To provide the DOE Federal community with an opportunity to discuss last-minute issues and concerns, we invite all Field Office Managers and their designees to participate in a complex-wide videoconference. The videoconference will be an opportunity to ask questions, exchange information, and discuss concerns with the implementation process.

The videoconference is scheduled for January 9, 2007, from 1:30-3:30 p.m. eastern time. Attached are a preliminary agenda and a list of the videoconference sites.
