with "is not limited to"

Page 35, line 9: delete ", but also ballot measures and other types of elections"

Page 35, lines 10 - 13: delete starting with "The Act..."

Without objection, the foregoing amendments were accepted.

Without objection, Footnote 22, on Page 28, of Agenda Document No. 04-11-D, was deleted.

Without objection, the italic language on Page 4, lines 9 through 14, of Agenda Document No. 04-11-D was changed to regular text.

Chairman Smith recognized Commissioner Toner,

MOVED to approve his proposed amendments, as submitted in <u>Agenda Document No. 04-11-F</u>, subject to the following items which were <u>withdrawn</u>:

"Page 5, line 7 strike "only"

"Page 5, line 19 after 'committees.'
Insert 'Accordingly, in light of BCRA
and the McConnell ruling, it is appropriate
for the Commission to require as a matter
of law that all communications made by
political committees that 'promote, support,
attack, or oppose' a Federal candidate be
paid for entirely with funds subject to the
limits, prohibitions, and reporting requirements of FECA.' Also, after 'FECA...' (NOTE:
The footnote was retained in the amendments.)

[&]quot;Page 15, line 27 through page 16, lines 1-5 strike

[&]quot;Page 16, line 23 strike 'and do not refer to any non-Federal candidates.'

"Page 17, lines 23-24 strike 'for the following reasons.'

"Page 18, lines 4-6 strike beginning with 'Moreover' through the end of line 6

Page 34, Footnote 29, change the cite to 106.6(d).
