Shasta Unit • Whiskeytown - Shasta-Trinity National Recreation Area, Shasta-Trinity National Forest

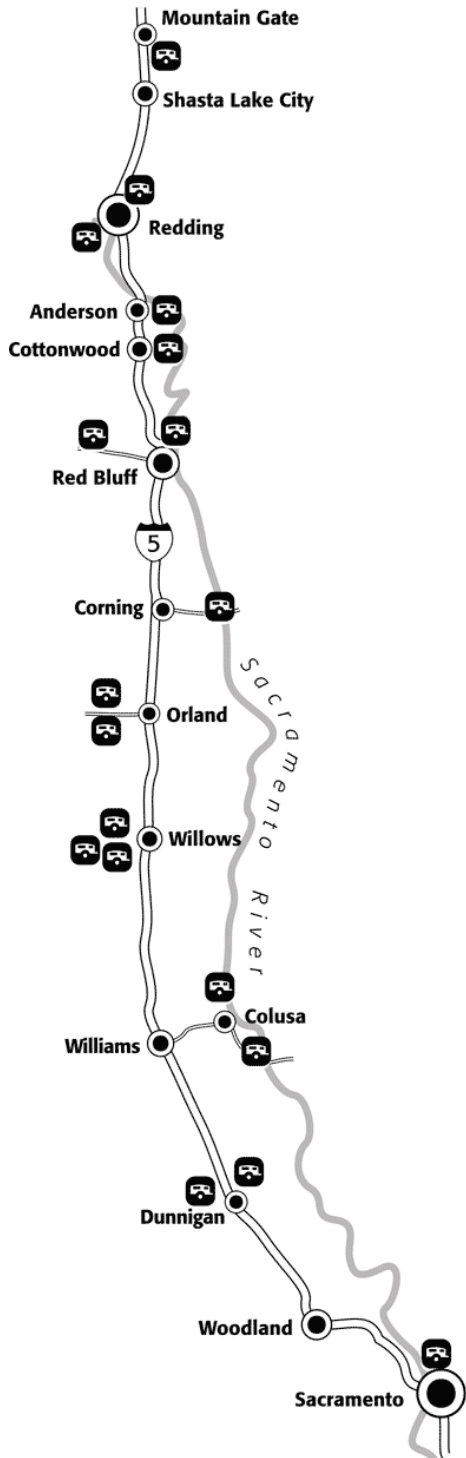

Redding to Sacramento



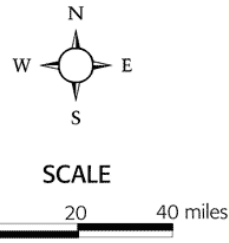
