Dear Mr. Burks:

This is to advise you that the Food and Drug Administration (FDA) has reviewed your web site at the Internet address <http://www.lifelinefoods.com> and has determined that the products "ACUTE COLD & FLU" and "ADD Attention" are promoted for conditions that cause the products to be drugs under section 201(g)(1) of the Federal Food, Drug, and Cosmetic Act (the Act) [21 U.S.C. § 321(g)(1)]. The therapeutic claims on your web site establish that the products are drugs because they are intended for use in the cure, mitigation, treatment, or prevention of disease. The marketing of these products with these claims violates the Act.

Examples of some of the claims observed on your web site include:

**ACUTE COLD & FLU**

**Claims for ingredients listed in this product:**

- "Echinacea - has been found to be antiviral, antibacterial, and antifungal. It is especially good ... as a first line of herbal defense against cold and flu."
- "Vitamin C - ... is commonly acknowledged to shorten the duration and lessen the severity of colds."
- "Elderberry -... One study shows constituents of elderberry can block flu viruses from invading healthy cells."
- "Myrrh - is a powerful antiseptic on the mucous membranes, and is an expectorant for colds and chest congestion. It helps soothe inflammation and speeds the healing process."
- "Goldenseal - is a well known herb used to help relieve fever, chills, and achiness. It is often taken ... to fight infection and inflammation in the mucous membranes."
- "Zinc - .... It encourages proper infection-fighting levels."
- "Thyme - acts as an expectorant, loosening phlegm in the respiratory tract."
- "Ginger Root - has many antiviral compounds--reducing pain and fever, and suppressing coughing."
- "White Willow Bark - is effective in reducing fever, is known for its antiseptic, anti-inflammatory...properties."
- "Colloidal Silver - is one of the world's most powerful antimicrobial agents. It is a broad spectrum, disinfecting antibiotic alternative that can significantly reduce the length and severity of almost any bacterial infection."

Furthermore, the name of your product suggests that it is intended for use in the cure, mitigation, treatment, or prevention of colds and flu.

**ADD Attention**

The name of your product suggests that it is intended for use in the cure, mitigation, treatment, or prevention of attention deficit disorder.

Furthermore, your products are not generally recognized as safe and effective for the above referenced conditions and therefore, the products are also a “new drug” under section 201(p) of the Act [21 U.S.C. § 321(p)]. New drugs may not be legally marketed in the U.S. without prior approval from FDA as described in section 505(a) of the Act [21 U.S.C. § 355(a)]. FDA approves a new drug on the basis of scientific data submitted by a drug sponsor to demonstrate that the drug is safe and effective.

FDA is aware that Internet distributors may not know that the products they offer are regulated as drugs or that these drugs are not in compliance with the law. Many of these products may be legally marketed as dietary supplements if claims about diagnosis, cure, mitigation, treatment, or prevention are removed from the promotional materials and the products otherwise comply with all applicable provisions of the Act and FDA regulations.

Under the Act, as amended by the Dietary Supplement Health and Education Act, dietary supplements may be legally marketed with truthful and non-misleading claims to affect the structure or function of the body (structure/function claims), if certain requirements are met. However, claims that dietary supplements are intended to prevent, diagnose, mitigate, treat, or cure disease (disease claims), excepting health claims authorized for use by FDA, cause the products to be drugs. The intended use of a product may be established through product labels and labeling, catalogs, brochures, audio and videotapes, Internet sites, or other circumstances surrounding the distribution of the product. FDA has published a final rule intended to clarify the distinction between structure/function claims and disease claims. In addition, only products that are intended for ingestion may be lawfully marketed as dietary supplements. Topical products and products intended to enter the body directly through the skin or mucosal tissues, such as transdermal or sublingual products, are not dietary supplements. For these products, both disease and structure/function claims may cause them to be new drugs.

Certain over-the-counter drugs are not new drugs and may be legally marketed without prior approval from FDA. Additional information is available in Title 21 of the Code of Federal Regulations (21 C.F.R.) Parts 310 and 330-358, which contain FDA's regulations on over-the-counter drugs.

This letter is not intended to be an all-inclusive review of your web site and products your firm markets. It is your responsibility to ensure that all products marketed by your firm comply with the Act and its implementing regulations.
