# WEDNESDAY, FEBRUARY 4

#### Call to Order & Welcome

NGAC Chair Anne Hale Miglarese called the meeting to order at 8:30 a.m., welcomed the committee members and audience to the meeting, and summarized the meeting agenda. Ms. Miglarese noted that an opportunity for public comment would be provided during the afternoon of February 5. Ms. Miglarese reviewed the minutes from the October 15-16, 2008 NGAC meeting and called for approval.

DECISION: The NGAC adopted the minutes of the October 2008 NGAC meeting.

#### Remarks from FGDC Staff Director/DFO

Ivan DeLoatch, Staff Director of the Federal Geographic Data Committee, gave a summary of recent FGDC activities and initiatives, including the following:

- The FY 2008 FGDC Annual Report was completed in December 2008. The report was distributed to NGAC members.
- Upcoming FGDC meetings:

## **Transition/Economic Stimulus Discussion**

Karen Siderelis, the Geospatial Information Officer (GIO) for the Department of the Interior, provided a report on the Administration transition process and economic stimulus activities. Ms. Siderelis noted that she is serving as the acting Chair of the Federal Geographic Data Committee (FGDC) and that Mike Howell, the OMB Deputy Administrator for E-Government and Information Technology, is serving as acting Vice-Chair. During the transition period, FGDC has asked member agencies with political appointees serving as Senior Agency Officials for Geospatial Information (SAOGIs) to designate acting officials until new appointees are in place. Ms. Siderelis provided a brief update on recent FGDC meetings, including the October and December 2008 FGDC Steering Committee meetings and the ongoing monthly meetings of the FGDC Executive Committee.

Ms. Siderelis also provided an overview of FGDC activities in response to the economic stimulus bill, including a proposal on behalf of the FGDC that was developed by the Interior Department for funding of the Imagery for the Nation (IFTN) initiative, and a description of the planned Recovery.gov website. Ms. Siderelis also provided an update on the IFTN initiative. The IFTN team developed a draft project plan that was presented to the FGDC Executive Committee in December. The team is in the process of completing contracting and hosting/archiving strategies for Executive Committee review and guidance.

Anne Hale Miglarese provided an overview of non-federal transition activities and several proposals that were developed as possible components of the economic stimulus bill. Ms. Miglarese noted that the NGAC transition recommendations that were adopted at the October NGAC meeting were provided to several transition teams, including the Science and Technology Transition Teams. Ms. Miglarese also encouraged NGAC members provide the transition recommendations and other products, including the Changing Landscape White Paper, to appropriate officials as opportunities arise.

Ms. Miglarese and the committee discussed the background and development of several economic stimulus proposals that were developed during consideration of the Recovery Act. The group discussed possible reasons why the proposals were not adopted and strategies to more effectively communicate the value and benefits of geospatial technology. The committee also discussed opportunities to utilize geospatial technology to more effectively implement the various components of the Recovery Act. The NGAC also discussed the creation of a new subcommittee to document lessons learned from the economic stimulus bill and to help plan for any subsequent, similar opportunities.

#### The National Map

Allen Carroll and Mark DeMulder (USGS) led a discussion of The National Map (TNM) and the recent activities of the NGAC TNM Subcommittee.

<u>Mark DeMulder</u> provided an overview of The National Map program, including the history of the program, its evolution over time, and the current goals and objectives of the program.

<u>Jeff Simley</u> of USGS provided an overview of the National Hydrography Database, one of the base layers of TNM.

<u>Kari Craun</u> of USGS provided an overview of the TNM topographic mapping strategy, including a description of plans for the "next generation" of topographic maps and a discussion of the technical issues and trade-offs involved in developing the updated product.

Allen Carroll described the recent meetings of the TNM Subcommittee and interactions with the USGS TNM leadership group. Mr. Carroll presented draft subcommittee conclusions and recommendations for consideration by the full committee. The committee discussed multiple aspects of the TNM program and the subcommittee's recommendations. Varied opinions were offered regarding the scope and objectives of the program, the roles and responsibilities of federal and non-federal participants, and the customers and audience for the products of the TNM program. The NGAC did not reach consensus on recommendations related to The National Map. However, the committee agreed upon the following actions:

**ACTION:** The TNM Subcommittee will send a request to NGAC members asking for additional concerns, issues, and questions to be addressed regarding the TNM.

**ACTION:** The TNM Subcommittee will work with USGS to develop draft advice on commercial licensing of data.

#### Governance/Circular A-16 Discussion

Dennis Goreham, Ivan DeLoatch, and Lew Sanford (FGDC) discussed the recent activities of the NGAC Governance/A-16 Subcommittee, the recently-developed OMB Circular A-16 Supplemental Guidance, and FGDC/NDSI governance issues. Mr. DeLoatch and Mr. Sanford provided an overview of the purpose and content of the Supplemental Guidance, which was developed as a component of the Geospatial Line of Business (LoB) initiative. The purpose of the Supplemental Guidance is to:

- Clarify the intent of OMB Circular A-16
- Promote portfolio management of A-16 themes and associated datasets
- Enhance coordination and collaboration of agencies and partners toward completion of A-16 data themes and datasets
- Develop a process to modify A-16 themes and datasets to reflect the current business needs of Federal agencies and their partners.

The Supplemental Guidance includes the following major components:

- Roles and Responsibilities
- Lexicon of Geospatial Terminology
- Stages of the Geospatial Data Lifecycle
- Geospatial Data Theme Principles

During the development of the Supplemental Guidance, the Governance/A-16 Subcommittee reviewed draft versions and offered comments. Mr. Sanford and Mr. Goreham reviewed the subcommittee's comments and the process the LoB team followed to address the comments.

Dennis Goreham summarized the feedback and reactions of the subcommittee and described remaining issues identified by the subcommittee. The NGAC met in small discussion groups to discuss A-16 and governance issues and identified a set of priority issues. The committee agreed to conclude the discussion on Day 2 of the meeting.

## **NGAC** Vision

Zsolt Nagy provided an update on the NGAC Vision Subcommittee's activities to date, including the development of a draft Strategic Vision, the results of the review and comment process, and a description of the final draft for consideration by the committee as a whole. The committee discussed the final draft and agreed upon several minor changes.

DECISION: The NGAC approved the NGAC Strategic Vision as revised.

#### Land Parcel Data

Dave Cowen and Don Buhler (BLM) provided an update on parcel data activities. Following the NGAC's session on parcel data at the October 2008 NGAC meeting, the FGDC Steering Committee considered the NGAC's recommendations and directed the FGDC Cadastral Subcommittee to convene a stakeholder meeting to explore the potential uses of land parcel data for more effective management of mortgage and financial oversight programs and activities. The meeting is scheduled for May 7, 2009 in Washington, DC. Additional information about the parcel data activities is available on the Cadastral Subcommittee's website at www.nationalcad.org. The NGAC agreed on the following action:

**ACTION:** FGDC/Cadastral Subcommittee will provide information on Mortgage Crisis/Parcel Data Stakeholder outreach meetings to NGAC and report back at May NGAC meeting.

# **THURSDAY, FEBRUARY 5**

#### Welcome, Summary of Day 1, Overview of Agenda

The Chair convened the second day of the meeting at 8:00 a.m., reviewed the previous day's activities, and provided an overview of the agenda for the day.

#### **Partnerships**

Jerry Johnston and Gene Schiller provided an update on the activities of the NGAC Partnerships Subcommittee, which was established at the October 2008 NGAC Meeting. The purpose of the subcommittee is to develop recommendations to facilitate productive partnerships to enable the efficient and effective advancement of the NSDI. The subcommittee's first task was to issue a Call for References for an "environmental scan" of existing geospatial partnerships and collaborative models. The environmental scan will provide a baseline of information about successful existing models and best practices. Based upon the results of the Call for References, the subcommittee will develop an action plan for consideration by the NGAC. The NGAC agreed on the following actions:

**ACTION:** NGAC members provide feedback to Partnership Subcommittee's Call for References by February 27.

**ACTION:** Partnerships Subcommittee will summarize results of Call for References, prepare draft project plan, and report back to NGAC.

#### The National Map

The NGAC concluded its discussion of The National Map. See NGAC actions listed on page 3 of these minutes.

## Governance/OMB Circular A-16

The NGAC reviewed the feedback and conclusions from the Day 1 discussion groups. The NGAC reviewed and discussed a draft recommendation developed by the subcommittee. The NGAC agreed on the following recommendation as revised:

**RECOMMENDATION:** The NGAC approved the following recommendation to the FGDC regarding governance:

- Whereas Executive Order 12906 and OMB Circular A-16 designate geospatial data themes and assign federal agency stewards for those themes;
- Whereas most agencies have not been provided designated resources to meet stewardship responsibilities;
- Whereas some agencies have not produced plans to accomplish stewardship responsibilities;
- Whereas OMB has not been able to assemble consistent and accurate budgetary crosscuts for geospatial activities to implement stewardship responsibilities;
- Whereas agencies have not been held accountable for meeting stewardship responsibilities; and
- Whereas the coordination, duplication avoidance, and partnering requirements of Executive Order 12906 and OMB Circular A16 remain unsatisfied not only among Federal agencies, but also with non-Federal stakeholders:

Now Therefore; Be It Resolved:

- That the NGAC recommends that the FGDC encourages and supports the Administration in the use of geospatial data and technologies to transform government operations and provide accountability and savings across geospatial activities, by:
- Reaffirming Executive Order 12906 and revising it to increase accountability;

- Strengthening direct OMB enforcement of the reporting requirements in Circular A-16;
- Implementing performance measures
- Coordinating and working in partnership with Federal, State, Tribal, and local government agencies and the private sector, and building upon non-Federal data wherever practical; and
- Strongly considering the role of geospatial data and technology in transforming government operations while implementing the President's management agenda and formulating and executing the President's Budget.

#### **Public Comment Period**

The following input was provided during the public comment period:

Dennis Klein, Boundary Solutions, Inc. Mr. Klein offered comments on the relationship between open records, digital parcel maps, and property tax revenue growth. Mr. Klein provided handouts that were distributed to committee members.

### News and Notes Forum

<u>John Palatiello</u> provided a presentation on geospatial metrics, "You Can't Manage What You Can't Measure." The presentation described the need for better baseline information and metrics; the need for a more complete assessment of the scope of the geospatial market and Federal investments, contracts and grants; and the need for more effective metrics related to education, training, research and development. NGAC members discussed the presentation and the relationship of metrics to the development of a national geospatial strategy. The issue of metrics was identified as a possible topic to be discussed at a future NGAC meeting.

<u>Kass Green</u> provided an update on the planned ASPRS Industry Forecast project, which is being conducted in partnership with NGA and USGS. Charlie Mondello and George Hepner are leading this project for ASPRS.

**ACTION:** NGAC members provide suggestions and feedback on ASPRS Industry Forecast project to Charlie Mondello by end of February.

#### Communications

Kass Green described the role and activities of the Communications Subcommittee, including internal and external communications and outreach strategies. Ms. Green indicated that Mike Byrne is developing a draft op-ed article on NGAC activities and the development of a national geospatial strategy. Vaishal Sheth of FGDC provided a brief demonstration of the myUSGS Wiki site that has been established for use by the NGAC. Several members requested a more detailed follow-up briefing. The NGAC agreed on the following actions:

**ACTION:** FGDC staff will schedule demonstration of MyUSGS wiki site for NGAC members. FGDC staff will reset NGAC member passwords.

ACTION: NGAC Chair and DFO will review draft op-ed article and determine next steps.

## **NGAC Action Plan**

Anne Miglarese led a discussion of the NGAC Action Plan, focusing on accomplishments to date, current subcommittee activities, and potential topics for upcoming meetings. The NGAC agreed on the following actions:

ACTION: NGAC retired Vision Subcommittee and Changing Landscape Subcommittee.

**ACTION:** NGAC established new subcommittee to review development of economic stimulus proposals, identify lessons learned, and develop longer-term strategy for more effective cross-sector coordination.
