- 2 Instructions for Preparing FEC FORM 13 (Report of Donations Accepted for
- 3 Inaugural Committee)
- 4 Definitions
- 5 For purposes of this form:
- 6 Inaugural committee means the committee appointed by the Presidential-elect to
- 7 be in charge of the Presidential inaugural ceremony and functions, and activities
- 8 connected with the inaugural ceremony, and that has filed the letter required by
- 9 11 CFR 104.21(b).
- 10 Donation means a payment, gift, subscription, loan, advance, or anything of
- 11 value given to an inaugural committee.
- 12 Who Must File
- 13 FEC Form 13 must be filed by the chairperson or other officer identified in the
- 14 inaugural committee's letter-filing under 11 CFR 104.21(b).
- 15 When to File
- 16 The Commission must receive this report not later than 11:59 p.m. (Eastern
- 17 Time) of the 90th day following the date on which the Presidential inaugural
- 18 ceremony is held. If a supplement to this report is necessary, the Commission
- must receive that supplement no later than 11:59 p.m. (Eastern Time) of the 90th
- 20 day following the filing date of the report (or most recent supplement if a previous
- 21 supplement has been filed).
- 22 Where to File

- 1 File this Form with the Federal Election Commission, 999 E Street, N.W.,
- 2 Washington, DC 20463.
- 3 The inaugural committee must retain copies of its filings and related records for a
- 4 period of not less than three years from the date of filing.
- 5 Line By Line Instructions
- 6 LINE 1. Name and Address of Committee. Provide the requested information.
- 7 LINE 2. FEC Identification Number. Enter the FEC identification number
- 8 provided by the Commission in response to the letter-filing required by 11 CFR
- 9 104.21(b).
- 10 LINE 3a. Type of Filing. Check "Report" if this is your first Form 13 filing—due
- 11 within 90 days after the inauguration. Check "Supplement" if you are disclosing
- 12 donations accepted or refunds made since your previous Form 13 filing.
- 13 LINE 3b. New or Amendment. Check "New" if this is a new report or if you are
- 14 filing a supplement to a report. Check "Amendment" if you are correcting a
- previously filed report or supplement, and provide the filing date of the report or
- 16 supplement to which the amendment relates.
- 17 LINE 4. Covering Period. Enter the first and last dates of financial activity
- 18 covered by the filing; on the report these dates should begin with the date of
- 19 appointment by the President-elect and end with the closing date of the report,
- which should be a date 15 days or less from the date the report is filed. Note that
- 21 the first date covered by a supplement should be the day after the closing date of
- the report (or most recent supplement if a previous supplement has been filed)
- 23 and the last date covered by a supplement is the closing date of the supplement,

- which should be a date 15 days or less from the date the supplement is filed. For
- 2 amendments to a report or supplement, list the coverage period for the original
- 3 filing.
- 4 LINE 5. Total Donations Accepted. Provide the total donations itemized on all
- 5 Schedules 13-A filed since the committee's inception.
- 6 LINE 6. Total Donations Refunded. Provide the sum total of refunds made to
- 7 donors itemized on all Schedules 13-B filed since the committee's inception.
- 8 LINE 7. Net Donations. Provide the total net donations by subtracting the total
- 9 donations refunded (Line 6) from the total donations received (Line 5).
- 10 Provide the name and title of the committee officer designated in the letter-filing
- 11 to sign this report. The designated officer (see 11 CFR 104.21(b)) must sign and
- 12 date the report.
- 13 Instructions for Schedule 13-A (Itemized Donations Accepted)
- 14 For each donation of money or anything of value aggregating \$200 or more,
- provide the donor's name and mailing address, the amount of each donation, the
- 16 date of receipt by the inaugural committee and the aggregate total of donations
- 17 accepted to date from that donor.
- 18 After itemizing the donations, add the total amount to the total of any previously
- 19 itemized donations and enter the sum total on Line 5 of Form 13. (Optional: To
- 20 facilitate this calculation, subtotal each Schedule 13-A. (You may use multiple
- 21 pages.) Add the total on the last page of Schedule 13-A to the total amount
- previously reported on Line 5 of Form 13 (if any), and carry the total to Line 5 of
- 23 Form 13.)

- 1 Instructions for Schedule 13-B (Itemized Refunds of Donations)
- 2 For each refund of a reported donation made by the committee, enter the
- 3 payee's name and address, the date the refund was made and the amount.
- 4 After itemizing the refunds, add the total itemized to the total of refunds

| 4 | |
| 5 | The Commission has developed FEC Form 13 (Report of Donations |
| 6 | Accepted for Inaugural Committee) and accompanying instructions. FEC Form |
| 7 | 13 implements the reporting and filing requirements of section 308 of the |
| 8 | Bipartisan Campaign Reform Act of 2002, which amended 36 U.S.C. 510(b) to |
| 9 | require an inaugural committee to disclose donations of \$200 or more. In |
| 10 | general, authority for the promulgation of FEC forms is contained in 2 U.S.C. |
| 11 | §438(a)(8). |
| 12 | On (insert date), the Commission adopted regulations at 11 CFR 104.21 |
| 13 | to implement the disclosure requirements of 36 U.S.C. 510. These regulations |
| 14 | require the inaugural committee appointed by a President-elect to disclose |
| 15 | certain donations, and refunds of such donations, in a report filed with the |
| 16 | Commission no later than 90 days after the date of the Presidential inaugural |
| 17 | ceremony. See 69 Fed. Register (insert date and page of publication in Federal |
| 18 | Register). The Commission transmitted the final rules to Congress on (insert |
| 19 | date of transmittal). |
| 20 | The Commission anticipates that FEC Form 13 and its instructions will |
| 21 | become effective within ten legislative days of the date of their transmittal to |
| 22 | Congress. |
