

We are encouraging individuals to take action (see http://www.pfaw.org/pfaw/general/default.aspx?oid=14751), and share this info with other nonprofits they may be affiliated with.

The following is a SUMMARY of the points raised in the comments:

- 1. The proposed rules will seriously impede the ability of nonprofit organizations to engage in issue advocacy.
- 2. The proposed rules will restrict the ability of nonprofit organizations to conduct nonpartisan voter participation activities.
- 3. The proposed rules will restrict the ability of nonprofit organizations to communicate with their members on legislative and public policy matters.
- 4. Congress has addressed the core issues raised in the proposed rules and it stopped far short of the radical proposals now being considered.
- 5. The Commission lacks the administrative tools to examine the issues raised in the proposed rules and, in any event, there is insufficient time to carry out this examination under the current expedited schedule.
- 6. Congress and not the Commission is the appropriate institution to resolve the delicate political issues at the core of the proposed rules.

Dear Sir:

Recent information available to me has implied that the FEC may be considering banning the broadcast of informative election ads by an organization known as GRASSFIRE.ORG. The same information indicates that this would be an arbitrary in that you would not be banning MOVEON.ORG! Should this info be accurate, as a citizen and a veteran I take considerable offense that such a decision of unequal censure could be considered. This action would be tampering with the elective process.

Some of us may appreciate our President, some of us may dislike him but that is what a fair and equal elective process is for. I resent that a billionaire immigrant comes here and attempts to buy our election process with his money through MOVEON.ORG and even more so in lobbying for censure of GRASSFIRE.ORG, an equalizing element to his insults and disrespect for the Presidency, the Office and our Nation.

As a veteran I have been seriously insulted by MOVEON's accusation of President Bush being compared to Adolf Hitler. Our President did not kill 6 million Jews, or another 6 million comprised of Jehovah Witnesses, Gypsies, resistive Christians and homosexuals.
