Overview of Regulations

- Regs governing FECA are at

20 CFR parts 10 and 25

part 10 is major claims issues, part 25 is foreign cases

Subpart A-- General Provisions

- *10.1-10.18*
- Discusses the FECA, who administers it, defines key terms and lists key forms
- Also addresses records
 - ◆ confidentiality (*10.10*)
 - ◆ custody & control (*10.11*)
 - ◆ copies (*10.12*)
 - ◆ correction (*10.13*)
- FECA fraud & felony (*10.16-10.18*)

Subpart B--Filing Notices and Claims

- *10.100-10.127*
- When & how claims are filed
 - ◆ traumatic injury (*10.100*)
 - ◆ occupational disease (*10.101*)
 - ◆ wage loss (*10.102*)
 - ◆ permanent impairment (*10.103*)
 - ◆ recurrence (*10.104*)
 - ◆ death benefits (*10.105*)
- Employer responsibilities (*10.110-10.113*)
- Employee responsibilities--evidence needed (*10.115-10.121*)
- Issuance of initial decisions (*10.125-10.127*)


Subpart C--Continuation of Pay

- *10.200-10.224*
- Traumatic injury, filed on CA-1 w/in 30 days (*10.205*)
- 7 reasons OWCP may deny COP (*10.220*)
- To use COP, disability must begin within 30 days from DOI or, in case of a recurrence, within 45 days of first return to work after initial disability (*10.205-10.207*)

Subpart D-- Medical & Related Benefits

- *10.200-10.337*
- Change in attendant's allowance policy--\$1,500, to be billed as medical expense, not, as before January 4, 1999, added to compensation payment (*10.314*)
- Conflict of medical opinion--weight of medical evidence (*10.321*)
- Medical reports should be submitted directly to OWCP (*10.331*)
- Partial reimbursement due to fee schedule application (*10.337*)

Subpart E--Compensation and Related Benefits

- 
- *10.400-10.441*
 - Explanation of compensation payment procedures (*10.400-10.425*)
 - No allowance for lump sum payments of wage-loss compensation (*10.422*)
 - Discussion of overpayment declaration & collection (*10.430-10.441*)

Subpart F--Continuing Benefits

- *10.500-10.541*
- **Employer responsibilities** (*10.505-10.509*)
 - ◆ advise employee in writing of obligation to RTW and of alternate positions available or accommodations that can be made
- Employer may use CA-17 to obtain medical progress report, but cannot contact physician by phone or visit (*10.506*)
- Job offers, to be suitable, should be in writing with specific duties & requirements (*10.507*)

Subpart F--Continued

- **Employee responsibilities** (10.515-10.537)
 - ◆ must resume regular employment if able, or seek work if unable to perform DOI job (10.515)
 - ◆ must advise physician that work is available and ask him/her to provide limitations (10.515)
 - ◆ must accept a suitable job or show why refusal is justified (10.517)
 - ◆ must undergo vocational rehabilitation as directed (10.519)
 - ◆ must report employment activities and dependent status when required (10.525-10.537)
- **Section F also discusses termination of compensation** (10.540 & 10.541)

Subpart G--Appeals Process

- *10.600-10.628*
- Reconsideration process (*10.605-10.610*)
 - ◆ Review under Director's own motion (*10.610*)
- Hearings (*10.615-10.622*)
 - ◆ Oral hearing or review of the written record (*10.617 & 10.618*)
 - ◆ Subpoenas may be requested (*10.619*)
 - ◆ Employer's role (*10.621*)
 - ◆ change in rules for postponing hearing (*10.622*)
- ECAB (*10.625 & 10.626*)

Subpart H--Special Provisions

- Representation (10.700-10.703)
 - ◆ one designated rep (10.700)
 - ◆ Federal employee can be rep only when immediate family member or unpaid union rep (10.701)
 - ◆ change in fee approval (10.703)
- Third party liability (10.705-10.719)
- Special Act cases (10.725-10.741)
 - ◆ Federal Jurors (10.725-10.727)
 - ◆ Peace Corps (10.730 & 10.731)
 - ◆ LEO (10.735-10.741)
