In addition to sampling variability, the ACS estimates are subject to nonsampling error (for a discussion of nonsampling variability, see Accuracy of the Data). The effect of nonsampling error is not represented in these tables.

Notes:

Ancestry listed in this table refers to the total number of people who responded with a particular ancestry; for example, the estimate given for Russian represents the number of people who listed Russian as either their first or second ancestry. 
NOTE. HOUSEHOLDS AND FAMILIES: In 2007 there were 283,000 households in Congressional District 4 (110th Congress). The average household size was 2.5 people.

Families made up 70 percent of the households in Congressional District 4 (110th Congress). This figure includes both married-couple families (53 percent) and other families (17 percent). Nonfamily households made up 30 percent of all households in Congressional District 4 (110th Congress). Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.


NATIVITY AND LANGUAGE: Four percent of the people living in Congressional District 4 (110th Congress) in 2007 were foreign born. Ninety-six percent was native, including 62 percent who were born in Oklahoma.

Among people at least five years old living in Congressional District 4 (110th Congress) in 2007, 7 percent spoke a language other than English at home. Of those speaking a language other than English at home, 53 percent spoke Spanish and 47 percent spoke some other language; 35 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2007, 79 percent of the people at least one year old living in Congressional District 4 (110th Congress) were living in the same residence one year earlier; 11

percent had moved during the past year from another residence in the same county, 5 percent from another county in the same state, 4 percent from another state, and 1 percent from abroad.

Geographic Mobility of Residents of Congressional District 4 (110th Congress), Oklahoma in 2007



EDUCATION: In 2007, 87 percent of people 25 years and over had at least graduated from high school and 23 percent had a bachelor's degree or higher. Thirteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Congressional District 4 (110th Congress) was 197,000 in 2007. Nursery school and kindergarten enrollment was 24,000 and elementary or high school enrollment was 119,000 children. College or graduate school enrollment was 54,000.

The Educational Attainment of People in Congressional District 4 (110th Congress), Oklahoma in 2007



DISABILITY: In Congressional District 4 (110th Congress), among people at least five years old in 2007, 17 percent reported a disability. The likelihood of having a disability varied by age - from 6 percent of people 5 to 15 years old, to 15 percent of people 16 to 64 years old, and to 46 percent of those 65 and older.

INDUSTRIES: In 2007, for the employed population 16 years and older, the leading industries in Congressional District 4 (110th Congress) were Educational services, and health care, and social assistance, 23 percent, and Retail trade, 11 percent.

OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Management, professional, and related occupations, 32 percent; Sales and office occupations, 25 percent; Service occupations, 17 percent; Production, transportation, and material moving occupations, 14 percent; and Construction, extraction, maintenance and repair occupations, 11 percent. Seventy-one percent of the people employed were Private wage and salary workers; 21 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.


TRAVEL TO WORK: Eighty-one percent of Congressional District 4 (110th Congress) workers drove to work alone in 2007, 11 percent carpooled, less than 0.5 percent took public transportation, and 3 percent used other means. The remaining 4 percent worked at home. Among those who commuted to work, it took them on average 20.9 minutes to get to work.

INCOME: The median income of households in Congressional District 4 (110th Congress) was \$45,346. Eighty-one percent of the households received earnings and 19 percent received retirement income other than Social Security. Twenty-seven percent of the households received

Social Security. The average income from Social Security was \$13,899. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2007, 13 percent of people were in poverty. Sixteen percent of related children under 18 were below the poverty level, compared with 8 percent of people 65 years old and over. Nine percent of all families and 31 percent of families with a female householder and no husband present had incomes below the poverty level.


Poverty Rates in Congressional District 4 (110th Congress), Oklahoma in 2007

POPULATION OF Congressional District 4 (110th Congress): In 2007, Congressional District 4 (110th Congress) had a total population of 744,000 - 372,000 (50 percent) females and 371,000 (50 percent) males. The median age was 34.9 years. Twenty-five percent of the population was under 18 years and 12 percent was 65 years and older.

The Age Distribution of People in Congressional District 4 (110th Congress), Oklahoma in 2007



For people reporting one race alone, 83 percent was White; 7 percent was Black or African American; 5 percent was American Indian and Alaska Native; 2 percent was Asian; less than 0.5 percent was Native Hawaiian and Other Pacific Islander, and 2 percent was Some other race. Six percent reported Two or more races. Six percent of the people in Congressional District 4 (110th Congress) was Hispanic. Seventy-five percent of the people in Congressional District 4 (110th Congress) was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2007, Congressional District 4 (110th Congress) had a total of 322,000 housing units, 12 percent of which were vacant. Of the total housing units, 77 percent was in single-unit structures, 14 percent was in multi-unit structures, and 9 percent was mobile homes. Twenty-five percent of the housing units were built since 1990.

The Types of Housing Units in Congressional District 4 (110th Congress), Oklahoma in 2007



OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2007, Congressional District 4 (110th Congress) had 283,000 occupied housing units - 198,000 (70 percent) owner occupied and 85,000 (30 percent) renter occupied. Six percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Forty-two percent had two vehicles and another 23 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,050, nonmortgaged owners \$317, and renters \$598. Twenty-two percent of owners with mortgages, 10 percent of owners without mortgages, and 36 percent of renters in Congressional District 4 (110th Congress) spent 30 percent or more of household income on housing.
