Export and Downstream Product Coverage

As part of SIMA's expansion, we are adding monitors of Steel Mill Product exports and selected Downstream Steel Product exports and imports to the monitor. The Steel Mill Product export tables can currently be access from our website by selecting this link: **Steel Mill Exports (Census Data).** This monitor includes quantity, value and pricing data for the same product groups covered in the import monitor. While the table opens up to a monthly summary of the exports, annual data is also accessible through the link at the bottom of the monthly tables' pages.

The Downstream Steel Product tables, also available from this link: **Imports** and **Exports**, show monthly and annual import and export data for steel products such as springs, cold-formed shapes, fitting, flanges, and wire products such as nails, staples, hangers, wire rope, strand, cable, cloth, grill, netting, fencing and barbed wire.

Recent Notable Changes Addition to SIMA

We have also added a section to the monitor which details large shifts in import levels by country and product. We utilize a program that picks these country and product combinations according to large shifts up or down from the most current three month period in comparison to the previous nine month's average levels.
