Bradenton Police Department:

Funding for patrol vehicles for \$600,000.

The entity to receive funding for this project is the City of Bradenton, 100 West 10th Street, Bradenton (FL) 34205.

The funding would be used for vehicles to be used in the patrol division to respond to calls for service and enforce all applicable law. This request will cover the cost for approximately 20 vehicles for the Bradenton Police Department.

Charlotte County:

US-41 enhancements in Charlotte County (FL) for \$4,000,000.

The entity to receive funding for this project is Charlotte County, 18500 Murdock Circle, Port Charlotte (FL) 33948.

The funding would be used to design road enhancements to US-41 – a congested section connecting Tampa to Miami.

A regional reclaimed water system for \$1,000,000.

The entity to receive funding for this project is Charlotte County, 18500 Murdock Circle, Suite 536, Port Charlotte (FL) 33948.

The funding would be used to design and construct a five mile reclaimed water transmission main, reducing the need for potable water in southwest Florida.

Child Protection Center:

Child advocacy center in Sarasota (FL) for \$300,000.

The entity to receive funding for this project is the Child Protection Center, Inc., 1750 17th Street, Bldg. L, Sarasota (FL) 34234.

The funding would be used to implement the Child Protection Center's "Pillar of Hope" program to provide expanded counseling and medical services to abused children.

The funding would be used to replenish the beach to deal with ongoing erosion.

Fruitville Road streetscape project for \$1,000,000.

The funding would be used on a project that requires roadway, sidewalk and streetscape improvements for Fruitville road from US-301 to US-41.
