Dear Republican Colleague,

As the April 3 deadline for Member project requests is rapidly approaching, I would like to remind you of the House and Republican Conference standards regarding certifications and disclosure of Member requests.

To comply with the rules and standards set forth by the Republican Conference, the Majority Leadership, and the House Code of Conduct, Republican Members must:

- Post all requests on the Member's official website in accordance with Chairman Obey's new policy that the Committee will only consider a request if it has been posted online;
- Submit a Financial Certification letter into the online system to confirm no financial interest in the project/program (https://membersrequests.approps.house.gov). This letter should also include verification of compliance with Republican Standards for Member projects. Please also include a sentence certifying that you have posted your request information online in compliance with Chairman Obey's new rules;
- For those subcommittees that require paper copies of your requests, please submit the appropriate documents to both the Majority and Minority Appropriations Committee Offices;
- Submit a statement in the Congressional Record describing how the funds will be spent and justifying the use of the federal taxpayer funds before floor consideration of the bill containing the approved request.

For all Appropriations Committee requests, the Financial Certification letter MUST be provided through the on-line Member request process. Republican Members are advised to use the attached sample letter as a format for submission of their certifications - rather than the sample provided on the Committee's online request website - as the online sample letter does not contain the Republican certification information.

When submitting requests to the Republican Appropriations Committee Office, please staple or paper clip your request information by subcommittee, three-hole punch, and drop in the appropriate subcommittee drop-off box. Please do not leave requests at the door if the office is closed.
