Figure III.O.2-1. Cumulative MOEs for Children 1-2 Region F 1-Day Analysis at 95th Percentile

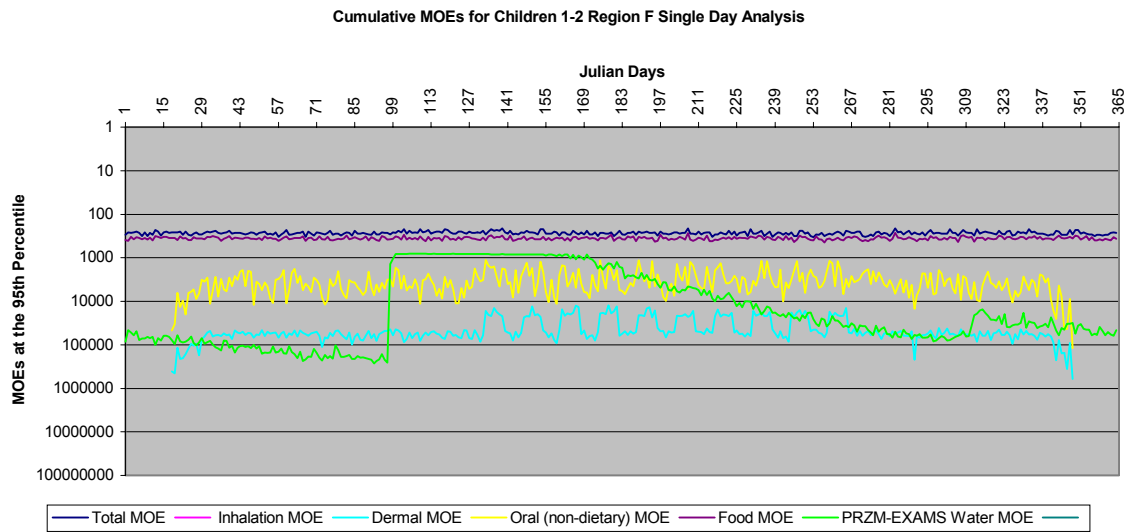
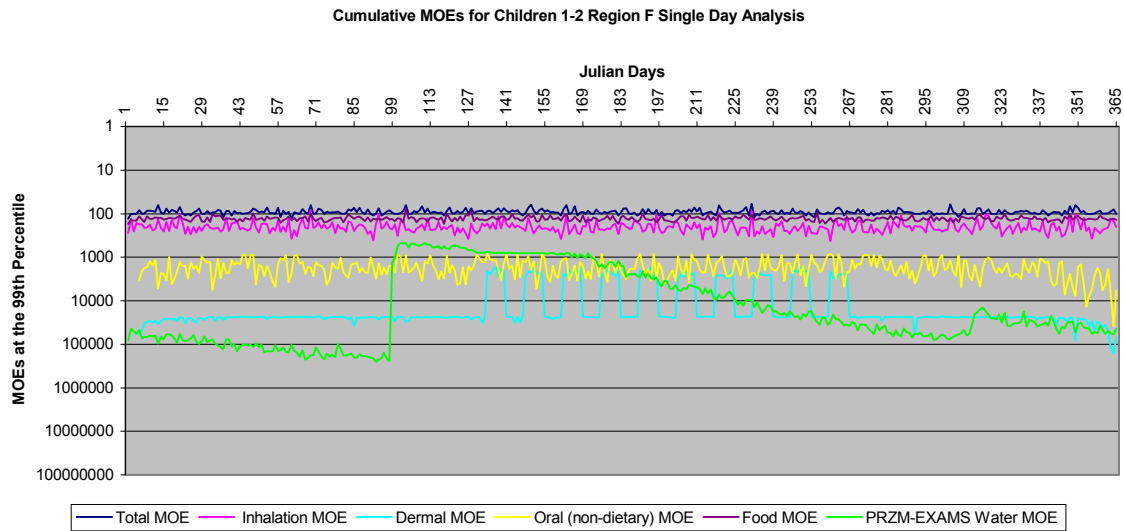


Figure III.O.2-2. Cumulative MOEs for Children 1-2 Region F 1-Day Analysis at 99th Percentile

Figure III.O.2-3. Cumulative MOEs for Children 1-2 Region F 1-Day Analysis at 99.5th Percentile

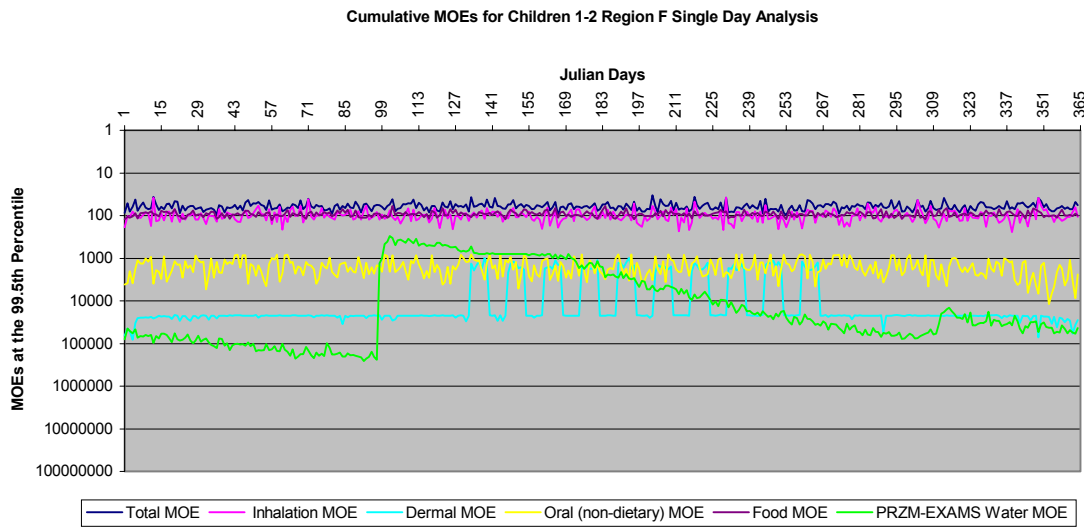
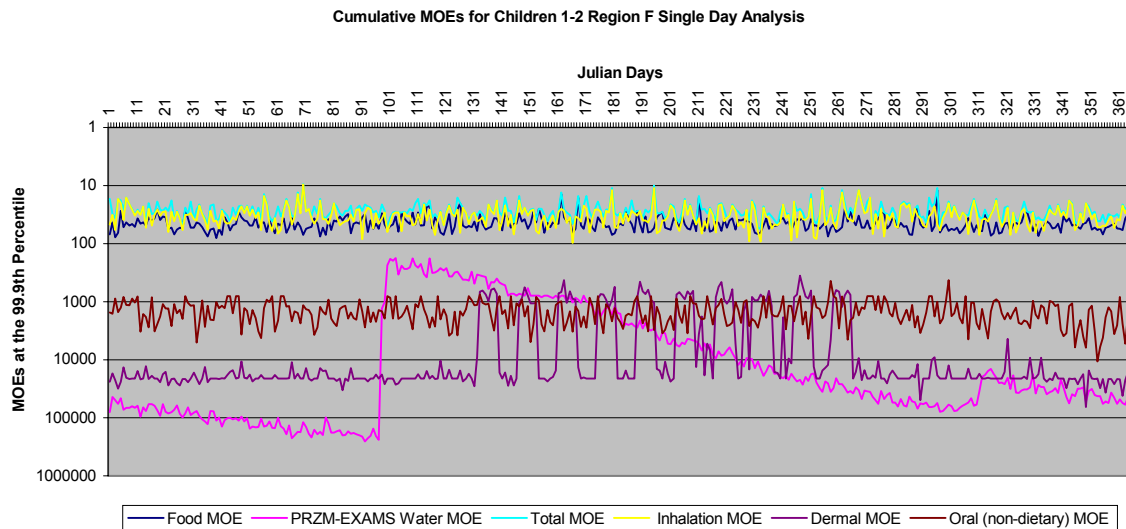


Figure III.O.2-4. Cumulative MOEs for Children 1-2 Region F 1-Day Analysis at 99.9th Percentile

Figure III.O.2-5. Cumulative MOEs for Children 1-2 Region F 7-Day Analysis at 95th Percentile

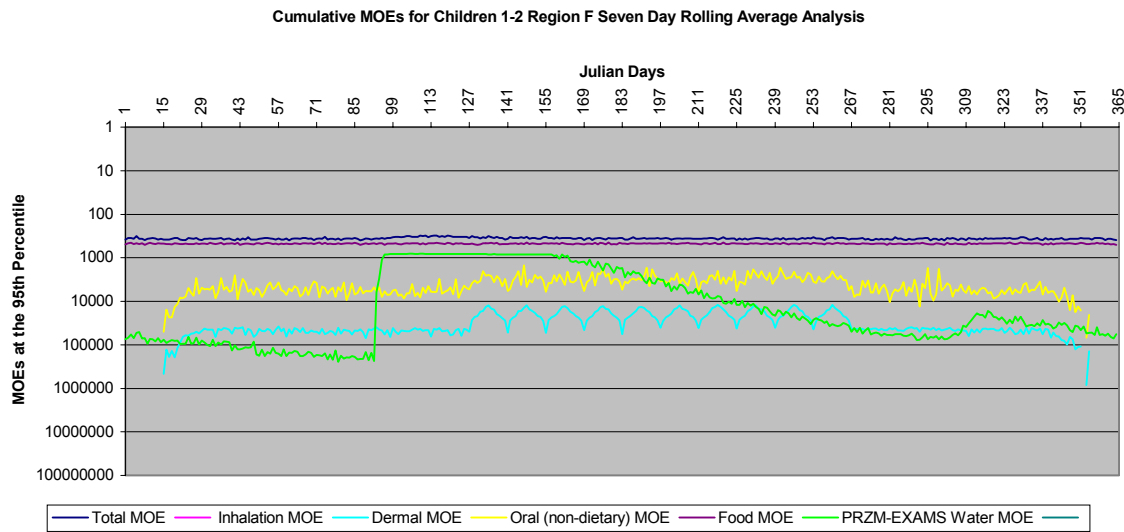
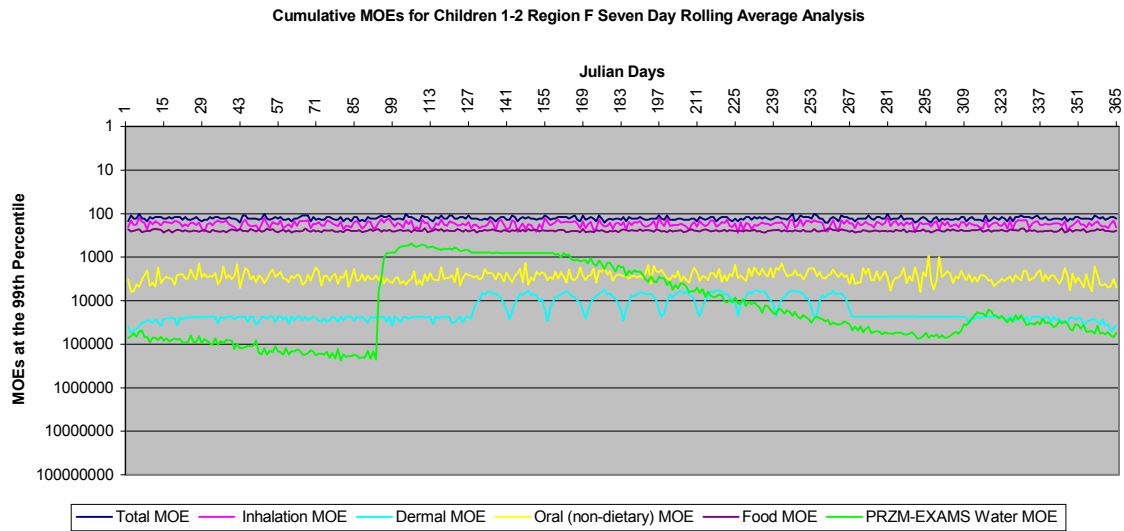


Figure III.O.2-6. Cumulative MOEs for Children 1-2 Region F 7-Day Analysis at 99th Percentile

Figure III.O.2-7. Cumulative MOEs for Children 1-2 Region F 7-Day Analysis at 99.5th Percentile

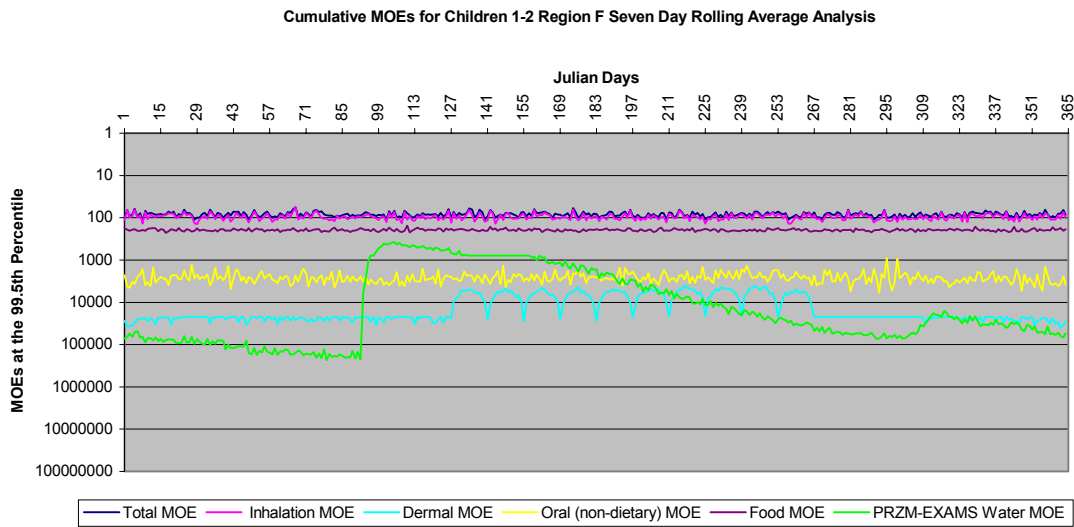
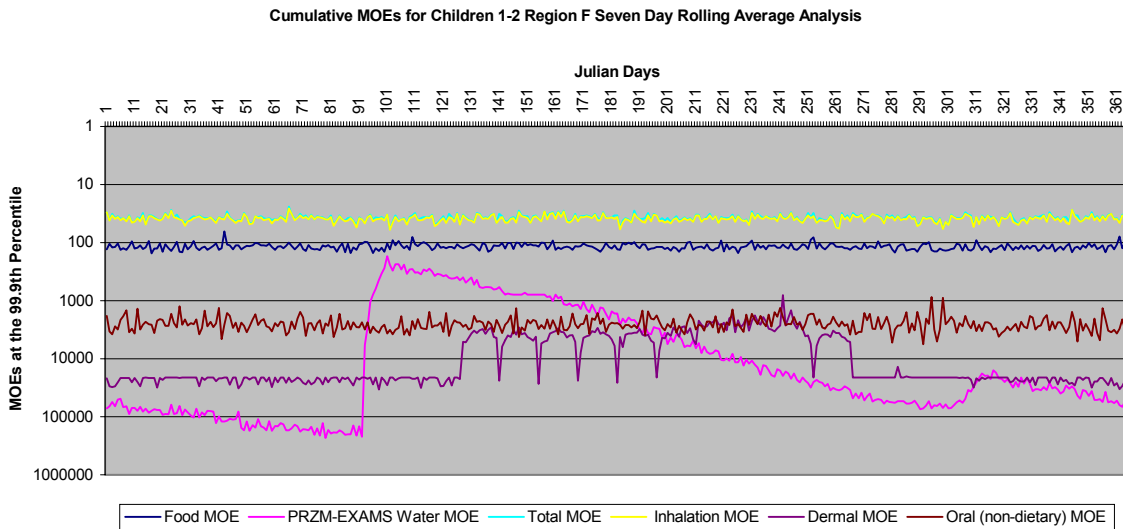


Figure III.O.2-8. Cumulative MOEs for Children 1-2 Region F 7-Day Analysis at 99.9th Percentile

Figure III.O.2-9. Cumulative MOEs for Children 3-5 Region F 1-Day Analysis at 95th Percentile

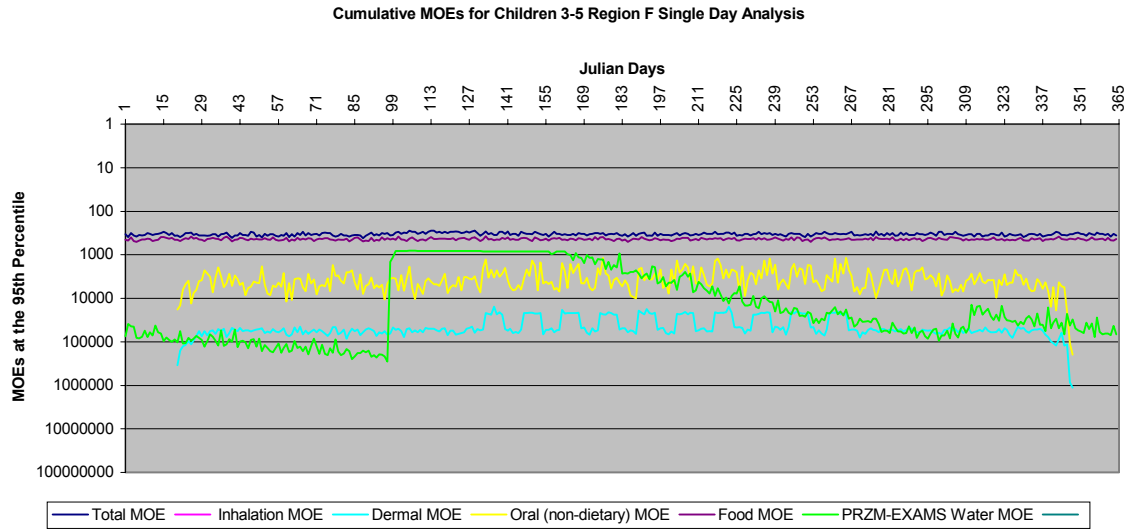
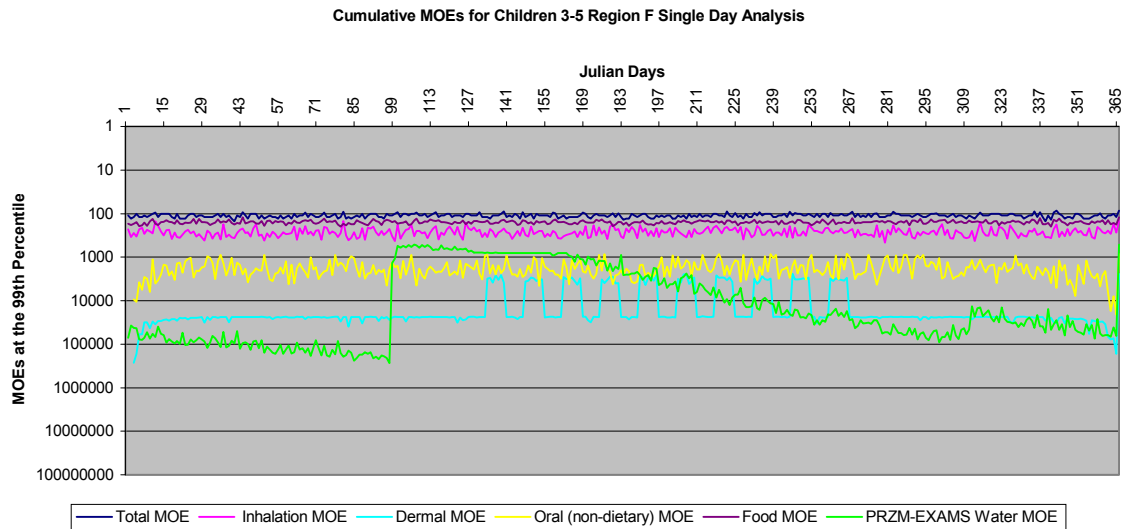


Figure III.O.2-10. Cumulative MOEs for Children 3-5 Region F 1-Day Analysis at 99th Percentile

Figure III.O.2-11. Cumulative MOEs for Children 3-5 Region F 1-Day Analysis at 99.5th Percentile

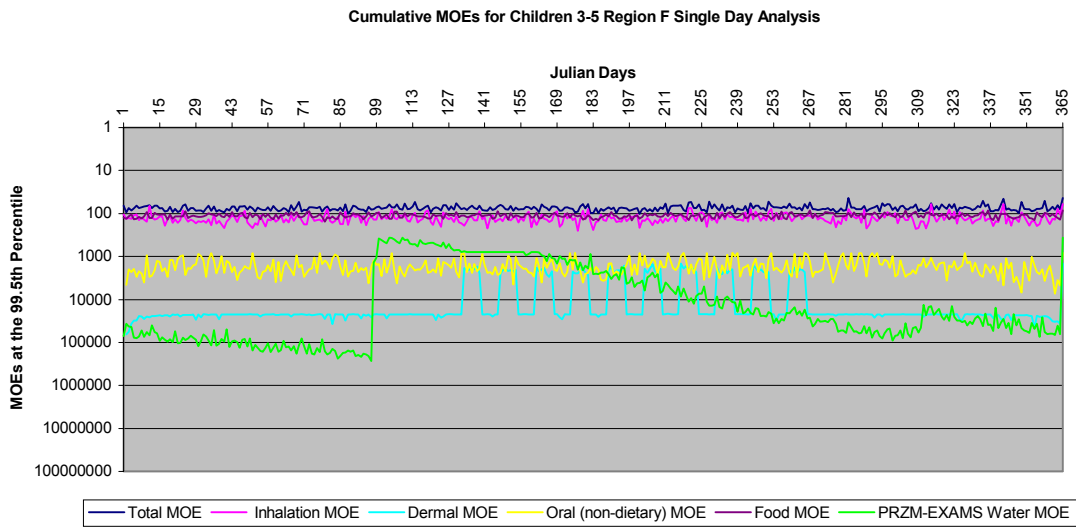
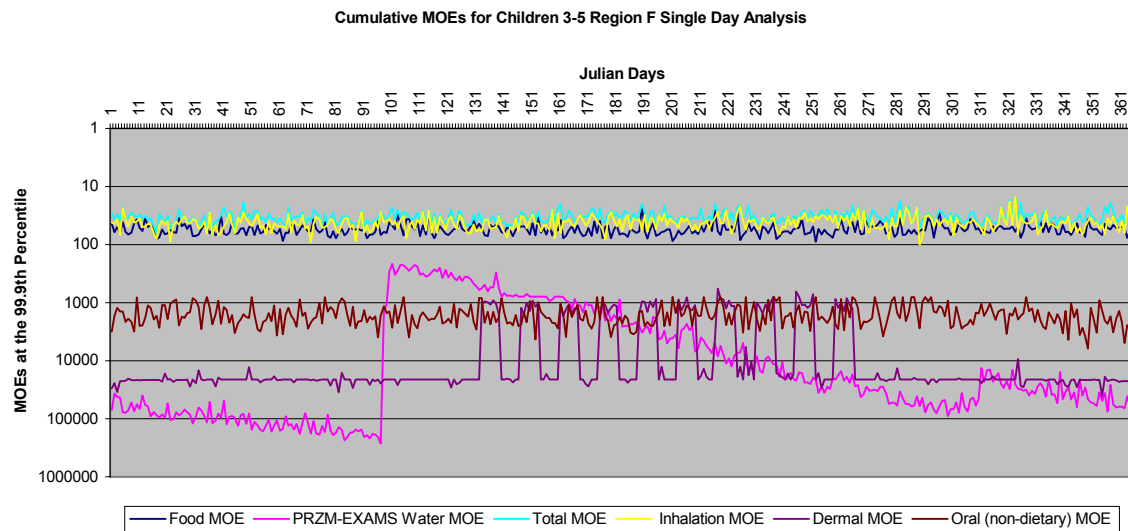


Figure III.O.2-12. Cumulative MOEs for Children 3-5 Region F 1-Day Analysis at 99.9th Percentile

Figure III.O.2-13. Cumulative MOEs for Children 3-5 Region F 7-Day Analysis at 95th Percentile

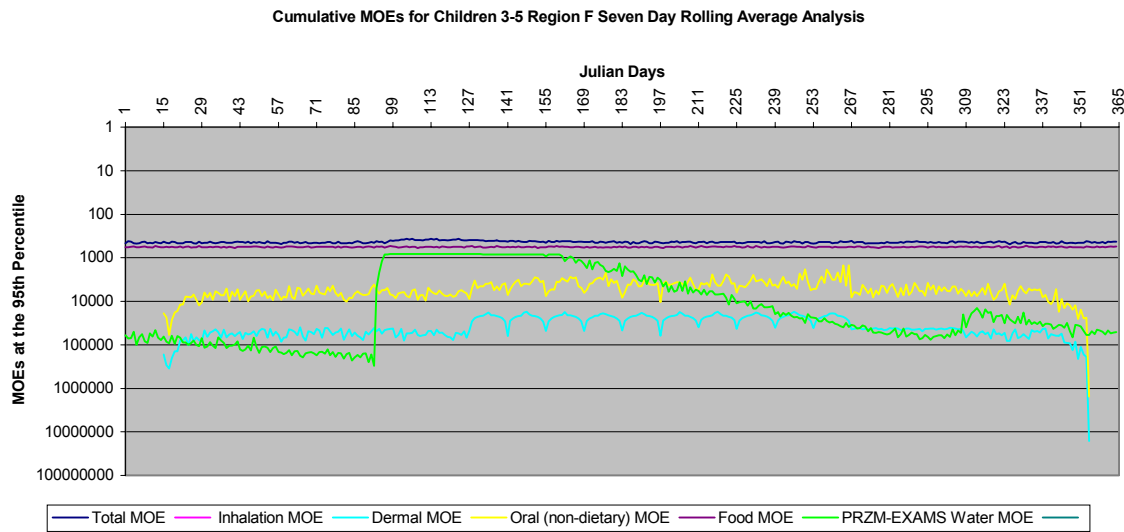
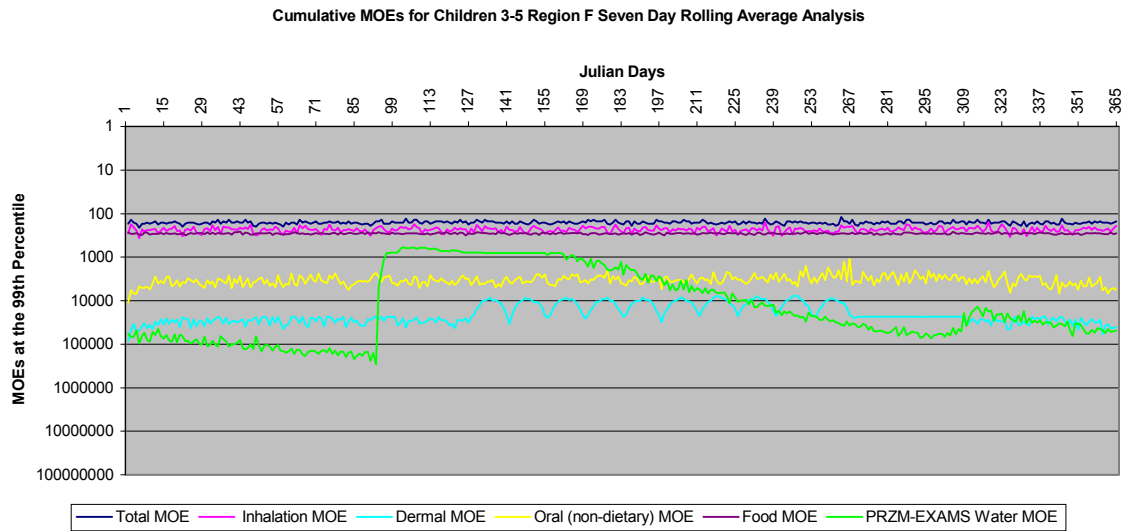


Figure III.O.2-14. Cumulative MOEs for Children 3-5 Region F 7-Day Analysis at 99th Percentile

Figure III.O.2-15. Cumulative MOEs for Children 3-5 Region F 7-Day Analysis at 99.5th Percentile

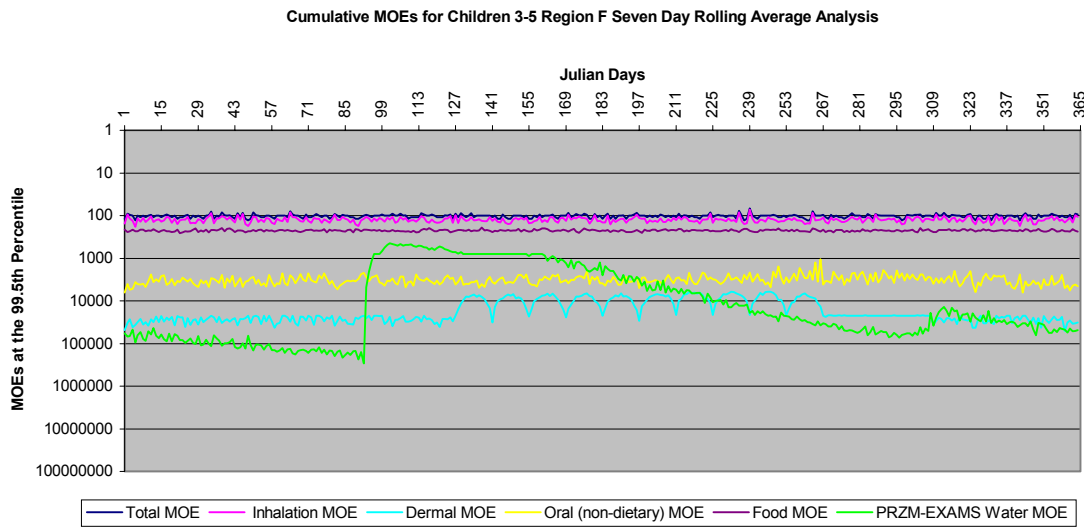
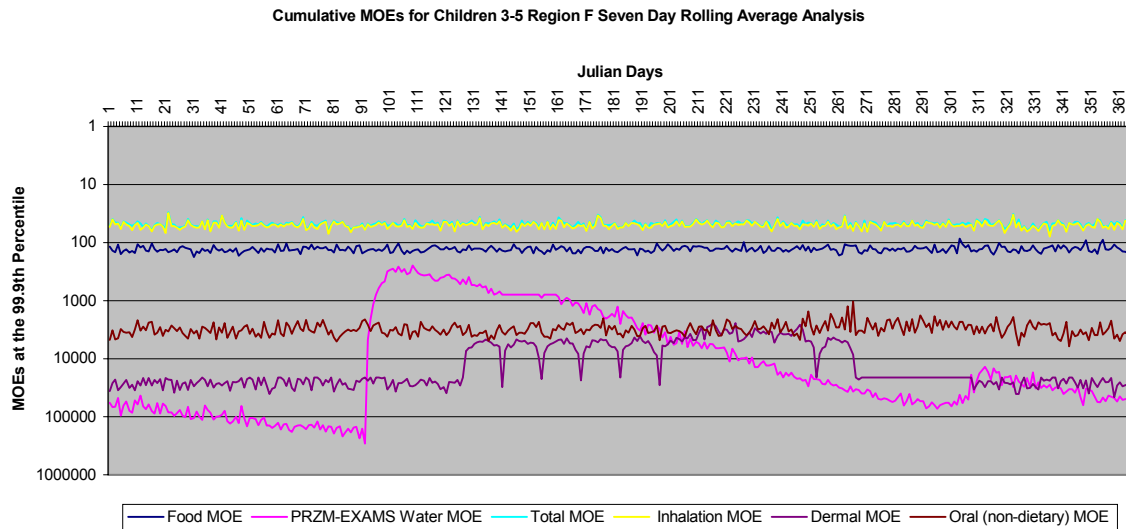


Figure III.O.2-16. Cumulative MOEs for Children 3-5 Region F 7-Day Analysis at 99.9th Percentile
