


UPCOMING MEETINGS

APRIL 8TH I&E COMMITTEE MEETING HELD AT DEPARTMENT OF JUSTICE OIG

I&E Committee Chair Johnnie Frazier opened the meeting by thanking Justice IG Glenn Fine for hosting the gathering. He welcomed Christine Shafik and Erin Reuther as the new committee support since Debbie



Holmes' departure to join NASA IG's staff.

IG Fine spoke about the inspections process at DOJ, reporting that his Office of Evaluation and Inspections, headed by Paul Price, performs a variety of reviews of internal and external programs and highlighted cooperative efforts among DOJ OIG units.

Paul described his inspection corps as a highly diverse unit with varied backgrounds, expertise, and program experience, increasing their ability for flexible assignments and enhanced cooperation with other Justice OIG units. For example, the I&E unit coordinated a review of judicial security with the OIG Office of Oversight and Review. The I&E unit also recently reviewed the communication and coordination of the Joint Terrorism and Anti-Terrorism Task Forces.

As part of the PCIE Domestic Policy Working Group, IG Fine noted DOJ's participation in an evaluation of information accessibility by offices of inspector general. The review addressed impediments, statutory differences, and best practices among federal, state, and local OIGs for denials or delays in gaining access to information. Frazier noted DOJ's coordination with other agencies as an example of projects that service the entire IG community.

QUALITY STANDARDS FOR INSPECTIONS BEING WIDELY CIRCULATED

The newly revised *PCIE Quality Standards for Inspections* is now available. Copies were distributed to PCIE, ECIE, and Roundtable members. At the request of the Association of IGs, we have provided 250 copies to state and local representatives. IG Boesz



also reports the standards have reached Beijing, China; Bonn, Germany; and Dublin, Ireland.

PROJECTS UNDER WAY

BEST PRACTICES GUIDE FOR
REVIEWING DISASTER PREPAREDNESS Jennifer Carmichael,
Defense Intelligence Agency
OIG, continues to develop a
best practices guide for reviewing disaster preparedness. Previously, Jennifer noted that the
Defense Intelligence Agency,
Commerce Department, and
National Reconnaissance Office
have disaster preparedness projects either under way or completed. Several agencies expressed interest in sharing in-

POTENTIAL I&E COMMUNITY
PROJECTS The I&E Committee
discussed potential joint projects
for the I&E community as well
as opportunities for us to work
together to, collectively, achieve
greater impact. Several of the
suggested topics included:
worker's compensation, healthcare, memorandums of understanding, e-gov, procurement,
homeland security, and foreign
affairs agencies' joint inspection.

COORDINATION AND COOPERATION OPPORTUNITIES. Discussions on the merits of electronic workpapers for the I&E community are continuing. Several I&E units are currently reviewing the feasibility of automated software, such as TeamMate.

Commerce OIG has successfully used automated tools on several projects for electronic workpapers and supporting documentation management. Discussions on how to best navigate the early—and often most difficult—stages of using automated workpapers are ongoing. Commerce staff is also available to provide program training. An Inspection Manual exchange is available for those OIGs that are developing or updating their own inspection manuals. Several I&E units are willing to share

TRAINING NEWS

I&E Committee and Roundtable members are working with the PCIE Human Resources Committee Working Group, assessing the capabilities of IGATI, FLETC, and the USPS Management Institute.

In-house "shared" training opportunities among the I&E community are continuing to be effective sources for leveraging limited training dollars and enhancing I&E training. In January, the Defense Intelligence Agency OIG provided 12 "free" slots for I&E Roundtable members to attend training on strategic decision making and negotiation, taught by Harvard professors.

Commerce OIG hosted a procurement training session at its Denver regional office in February and plans to host two additional procurement training sessions—at its Seattle regional office on April 26-28, 2005 and its Atlanta regional office on May 24-26, 2005—and has offered slots to other OIGs.
