

# COMMERCE OIG HOSTS JOINT I&E COMMITTEE AND ROUNDTABLE MEETING

On March 8th, I&E Committee
Chair Johnnie Frazier welcomed
Committee and Roundtable members
to the Commerce Department for a
joint meeting of the two groups. The
meeting focused around the theme
"We're In It Together" and how the
I&E community can work together
across agency lines. The meeting
was widely attended, with over 30
members in attendance. IGs Clinefelter, Kotz, and Rymer were among
the attendees.

Meeting participants reported on the many efforts by different OIGs to work together on crosscutting issues or to lend expertise or provide advice. This included Defense and Veterans Affairs (VA) who are working together on a review of how the two departments move people and their healthcare benefits from Defense to VA. Also, State, Defense, Justice, and U.S. Agency for International Development (USAID) are coordinating their efforts to counter narcotics in Afghanistan. IG Frazier emphasized the importance of working together as agents of change and breaking down barriers to cooperation that limit our potential. He stated that members of the OIG community should continue to leverage each others' expertise.

#### **ONGOING JOINT PROJECTS**

The I&E Committee and Roundtable members discussed several projects that emphasize cross-agency coordination. Members discussed the ongoing efforts in the OIG community to identify ways to strengthen management and oversight of the federal workers' compensation program and reduce fraud in the program.

Another project, Trade Promotion Coordination, resulted from Congress asking seven IGs (State, Commerce, Agriculture, Treasury, Small Business Administration, USAID, and the Millennium Challenge Corporation) to review how each of their agencies coordinates its trade promotion activities with other public and private trade organizations. Several cross-cutting issues were addressed during this review which was conducted by OIG inspection and audit offices: (1) there should be greater interagency involvement in the development of the National Export Strategy and federal export promotion goals; (2) trade lead development and dissemination need to be strengthened and the leads should be consolidated and available to U.S. businesses via a unified internet source; (3) a one-stop source for U.S.

government information on exporting and trade promotion programs is also needed; and, (4) Commerce and State should continue to work closely together to provide support to all U.S. overseas missions that provide commercial services to U.S. companies.

Several proposed joint reviews were also discussed during the meeting. Jill Schamberger, NSF OIG, presented information on her office's recent reviews on the publication of methods for tracking recommendations could be a valuable tool for an OIG.

federally funded scientific research. NSF OIG issued reports in December 2004, February 2006, and September 2006 on how federal research agencies hold grant recipients accountable. NSF OIG found that many stakeholders supported the agency doing more to ensure federally funded research is published. NSF OIG is willing to share its methodology on performing this type of review with other OIGs.

USDA OIG also presented information on a potential joint project. With a fairly new I&E unit, USDA OIG is looking to pull together best practices for tracking recommendations and conducting follow-up on I&E reports. IG Frazier noted that follow-up is important in the OIG community and learning the best
