Speaker Bios

Dana Brower is a consultant from Charlottesville, Virginia, and a partner with The Halcyon Group. She has been working in leadership development and training for more than 12 years, and facilitating learning on the topic of generational differences for seven years. Dana began work in the generations arena while serving as a Research Fellow at the Federal Executive Institute (FEI) – a training center for senior-level civil servants in Charlottesville – where she helped guide the Institute's efforts on Leadership Across Generations in the federal workplace. Today, she is conducting her own research project on generations at work.

John David Daigh, Jr., AIG for Healthcare Inspections, Department of Veterans Affairs joined the Department of Veterans Affairs as the Associate Director of Medical Consultation in OIG in January 2002 and was appointed as the AIG for Healthcare Inspections in January 2004. In this position, he is responsible for the OIG initiatives that review the quality of health care provided to veterans in Veteran Affairs' hospitals, clinics, and nursing homes, in addition to the care provided to veterans through various health care contracts. He provides consultation to the investigation and audit sections of the Office of the Inspector General.

Elise Ennis, AIG for Inspections, Department of Energy, was appointed AIG for Inspections in October 2008. Ms. Ennis is responsible for leading the Office of Inspections' programs, operations, policies, and resources. Inspections include reviews of economy, efficiency, and effectiveness of Department programs and activities, as well as reviews of administrative allegations.

Kenneth A. Gold has been the Director of the Government Affairs Institute at Georgetown University since 1997. He joined the Government Affairs Institute at the U.S. Office of Personnel Management in 1989 and was a member of its Senior Faculty until 1992, when he was named Director of the Institute. He served as GAI Director with OPM until it was privatized by the Federal Government in 1995. Dr. Gold is the author of articles on organizations and management, and of United States Foreign Economic Policy-Making (New York: Garland Publishing, 1987).

Daniel R. Levinson, IG for the Department of Health and Human Services (HHS) has headed the HHS OIG since September 8, 2004. As Inspector General, Mr. Levinson is the senior official responsible for audits, evaluations, investigations, and law enforcement efforts relating to HHS programs and operations. The Office of Inspector General is comprised of over 1500 professional staff members who provide leadership in promoting economy, efficiency, and effectiveness in HHS programs and addressing fraud, waste, and abuse.

Carlton (Carl) I. Mann is the AIG for Inspections at the Department of Homeland Security (DHS). His office provides the IG with a means to analyze programs quickly and to evaluate operational efficiency and vulnerability. His office reviews sensitive issues that arise suddenly, including congressional requests for studies that require immediate attention and that may involve any area of the department. His is the lead OIG office for reporting on DHS intelligence, international affairs, civil rights, civil liberties, science, and technology.

William (Brem) Morrison, III, AIG for Inspections and Evaluations, Department of Defense (DOD) was appointed in February 2004. The Inspections and Evaluations Directorate is a startup organization that was announced in September 2003 and formalized in March 2004. Mr. Morrison develops and utilizes independent inspection and evaluation processes to review the effectiveness of DoD activities.

Kathryn Newcomer is a professor at the Trachtenberg School of Public Policy and Public Administration at the George Washington University, where she is also Co-Director of the Midge Smith Center for Evaluation Effectiveness, home of The Evaluators' Institute. She is Director of the Doctoral program in Public Policy and Administration. She is also the Associate Director of the School. She teaches public and nonprofit program evaluation, research design, and applied statistics. She routinely conducts research and training for government agencies and nonprofit organizations on performance measurement and program evaluation. Dr. Newcomer has published five books, including Improving Government Performance, The Handbook of Practical Program Evaluation, and Meeting the Challenges of Performance-Oriented Government.

Michael Quinn Patton is an independent organizational development and program evaluation consultant. He is former President of the American Evaluation Association. He teaches regularly in The Evaluators Institute and The World Bank's International Program in Development Evaluation Training hosted annually in Ottawa. He is author of <u>Utilization-Focused Evaluation</u> and <u>Qualitative Research and Evaluation Methods</u>, and co-author of <u>Getting to Maybe: How the World Is Changed</u>.

Robert (Bob) B. Peterson, AIG for Inspections, Department of State (DOS) has worked in DOS's OIG since 1987. He previously worked for the U.S. Army Audit Agency in St. Louis, Missouri (1973 - 1977), the Department of Defense Office of Inspector General in Washington, DC (1977 - 1984), and the U.S. Information Agency Office of Inspector General in Washington, DC (1984-1987), before joining the DOS. He has inspected well over 100 posts and bureaus.

Debra J. Rog is an Associate Director with Westat and a Vice President of The Rockville Institute. Before joining Westat in January 2007, Dr. Rog directed the Washington office of the Center for Evaluation and Program Improvement (CEPI) for 17 years, and was a

Senior Research Associate in CEPI. She has over 25 years of experience in program evaluation and applied research. Dr. Rog has written numerous publications on evaluation methodology, housing, homelessness, poverty, mental health, and program and policy development and has edited numerous substantive and methodological volumes, including the Applied Social Research Methods. Besearch Methods.

Jon T. Rymer, Inspector General, Federal Deposit Insurance Corporation was nominated by President Bush and confirmed by the Senate on June 22, 2006. Mr. Rymer is a member of the Council of Inspectors General on Integrity and Efficiency, and has served as Chair of the Council's Audit Committee since July 2008.
