

George J. Opfer assumed the responsibility of Inspector General for the Department of Veteran Affairs (VA) on November 17, 2005. Mr. Opfer comes to VA after serving as the

Deputy Inspector
General for the Department of Labor.



Before joining Labor,

Mr. Opfer held the position of Inspector General for the Federal Emergency Management Agency (FEMA), where he served the agency for 8 years.

As Inspector General at VA, Mr.
Opfer is responsible for overseeing a
nationwide staff of auditors, inspectors, investigators, and support personnel. The VA OIG provides oversight and reviews of VA programs

including, healthcare, hospitals, and benefit administration.

Mr. Opfer attended St. John's University in New York, N.Y., where he earned a bachelor's degree in management and began his federal career as an agent with the U.S. Secret Service in its New York field office. While with the Secret Service, Mr. Opfer served in the Office of Inspections, the Presidential Protective Division, and the Washington, D.C. field office.

staff.


