### U.S. Health Attaché to Iraq, Terry Cline, Ph.D.

Previously, Dr. Cline served as Administrator for the Substance Abuse and Mental Health Services Administration (SAMHSA). As SAMHSA Administrator, Dr. Cline led the \$3.3 billion agency responsible for improving the accountability, capacity and effectiveness of the nation's substance abuse prevention, addictions treatment, and mental health service delivery systems. Dr. Cline will begin duties as the Commissioner of the Oklahoma State Department of Health in July 2009.
