To improve speed, convenience and document quality in the delivery of up-to-date biomedical and scientific journal articles....

# **Project Overview**

- 3 Year Grant, Funded by NIH/NLM
- 41 Facilities originally included in grant
  - 14 already had Ariel
  - During 3 yr project –Remaining 27 would receive new installation of Ariel/ computer equipment
- Official Start Date 8/01/03
- First Install was 12/10/03
- 11 facilities scheduled/10 facilities are completed\*
  - 1 install started but will not work-awaiting 4.0 install
  - \*Of 10 installs-2 have workarounds

Ariel Program Problems Email

- Will not work w/certain Email servers
  - Novell Groupwise
  - Some Internet email providers

'Quirky' Software Problems

- Cannot receive email- only from other Ariel Stations
- To send pdf's need to do a send to patron, a regular send will only send a tif file.
- Firewall Issues-IT Staff

**Understanding Ariel-**

What Ariel is-

Software program that centralizes the scanning, archiving, sending and receiving of documents.

Documents can be sent two different ways-

- Via email
- Straight file transmission (FTP)

# Understanding the Problems

**Understanding Ariel-**


What Ariel is not-



It is not an email system!

Therefore- to send and receive documents it must rely on an email server and firewall.

#### Understanding the Problems-Ariel Transmission of Documents

Understanding the Problems-Ariel sending/receiving via email

4.0/4.1 version fixes

- Allow Ariel to 'talk' to remainder of problem email systems
- Remove quirky problems-ability to receive documents via regular email

#### Understanding the Problems-Sending out Through the Firewall

Straight ftp (file transfer protocol) transmission needs two ports open on firewall (419,422)

No known technical problems other then these ports need to be opened by IT staff Understanding the Problems-Sending out Through the Firewall

Understanding IT Staff

Virus/Network Intrusion (Hacking)

HIPAA Compliancy (100%)

Some feel they were 'not told upfront'

#### Understanding the Problems-Sending out Through the Firewall

#### Solutions

- Collaboration/education upfront
  - Upfront collaboration-no surprises
  - Ariel System-Ports only open when an Ariel transmission is made-not wide open. White Papers on website/Ariel Staff to also explain
- Ariel sends documents-not patient information- No PHI Issue
- Installation outside firewall (Store and Forward)
