Natural Resources Working Group

The Millennium Challenge Corporation (MCC) works with the world's poorest countries and selects candidate countries as eligible to apply for funding from the Millennium Challenge Account (MCA) based on a country's performance against its peers on policies in three categories: ruling justly, investing in people, and economic freedom. In its authorizing legislation, MCC is also asked to use objective and quantifiable indicators to evaluate a country's demonstrated commitment to, among other things, economic policies that promote the sustainable management of natural resources. Thus far, MCC has been unable to identify an existing measure that meets our general criteria described below. To address this need, MCC has launched a public process to seek broad input from the academic community, public and private sector practitioners, and researchers at think tanks and non-governmental organizations.

MCC Board member Governor Christine Todd Whitman, former Administrator of the Environmental Protection Agency, is spearheading this process. On February 28, 2005, Governor Whitman and MCC CEO Paul V. Applegarth announced MCC's plan to establish a Natural Resources Working Group (NRWG) and kicked off this process by inviting comments and proposals from the public. MCC also enlisted the help of experts with backgrounds in natural and environmental sciences, economics, and public policy to individually rate proposals and submit an independent evaluation to MCC. MCC is working with a variety of individuals and institutions to host a series of meetings to discuss existing indicators or indices, criteria for such an indicator or index, and potential new indicators or indices.

As an intermediate measure, for the selection process for FY04 and FY05, MCC has provided its Board of Directors with supplemental information on:

As set out in our FY05 Selection Methodology and Criteria, MCC favors indicators or indices that:

- are developed by an independent third party;
- utilize objective and high-quality data;
- are analytically rigorous and publicly available;
- have broad country coverage and are comparable across countries;
- have a clear theoretical or empirical link to economic growth and poverty reduction;
- are policy-linked, i.e. measure factors that governments can influence within a two to three year horizon; and
- have broad consistency in results from year to year.
