An interview in the above entitled matter was held on Tuesday, October 26, 2004, commencing at 1:15 p.m., by:

2 MS. MCATEE: It is October 26, 2004, 1:15 p.m., 3 this is Nancy McAtee, fire and explosion specialist for the 4 National Transportation Safety Board. I am interviewing 5 Battalion Chief Greg Gudy with the Pasco County Fire 6 Department.

7 Chief, if you could just start me off from how you 8 found out about the incident on the Shuttle Express II, and 9 walk me all the way through from the time you left the 10 scene? Just a basic narrative.

11 CHIEF GUDY: Basically, I was informed by our 12 dispatch that we had an engine, Engine 11, responding to a 13 boat fire in Port Richey. They had requested an engine 14 company in there. It was just a notification. A 15 notification (indiscernible) on their part that you know 16 that we had units responding there.

17 So, I went about my business while the engine's 18 responded. At one point, when the captain got on the scene 19 and requested two additional engine companies, at that 20 point, I went en route to go there. Rick Carrabona 21 (phonetic sp.) who was being hired as an overtime battalion 22 chief, lives over nearby there so, he went to the scene to 23 see what he could assist on.

I continued and when I got there, basically, I just went around the back side of where the fire was. I observed the boat was out in the fire, they were actively, pretty much had it under control at that point. I went down and spoke with Captain Carrabona, who was somewhere along the way, had established command. I don't know exactly where it was.

I went down there, spoke with him for a little 6 7 while. Due to the fact that we were, you know, by the water, we -- I went ahead and took command from him for the 8 9 safety point of making sure that our personnel were 10 protected by -- I put a safety man in place out on the boat, 11 basically, set up a rehab down on the water's edge in the 12 rocks and everything, so our guys would have some areas in 13 there. They'd established kind of a rehab set up in there, 14 but that's basically the extent of what I did in there. 15 Then, once the fire was totally extinguished, it 16 started to drift, and at one point, we -- I got hold of the

17 Coast Guard, had them come over and try to assist with 18 securing the boat because it drifted to a point where our 19 line fell off of it, and there was still some fire burning 20 toward the front end of it, because of the extensive damage 21 that was done to it.

I went through the whole -- once it was totally extinguished and they were able to get it towed over and tied to one of the pilings. At that point then, I finally ended up leaving, leaving the scene back with Rick

Carrabona, and then I guess he turned it back over to Port
 Richey when they got back ashore --

3 MS. MCATEE: Okay.

4 CHIEF GUDY: -- because they were pretty much out 5 on the boat most of the time. I mean, periodically, their 6 captain would come in, but they basically didn't have a lot 7 of experienced personnel there, but it wasn't actually our 8 fire. We just -- I just set up command more for the safety 9 part of it.

10 MS. MCATEE: Have you done any other follow-up or 11 anything regarding this accident since you left that scene?

12 CHIEF GUDY: No, ma'am.

13 MS. MCATEE: Okay.

14 CHIEF GUDY: The only thing that I did that I 15 could say was actually being involved in the command part of 16 it right there, just you know, making sure no one got 17 injured or hurt.

MS. MCATEE: I understand that there was a request for the State Fire Marshal to come out. Did that request come from you?

21 CHIEF GUDY: Actually, that came from Port Richey,
22 because we were trying to figure out who'd investigate it.
23 Who did we need to call for an investigator?

24 MS. MCATEE: Okay.

25 CHIEF GUDY: Tried -- I think we asked the

1 sheriff's office that was there if they were -- who to 2 request -- whether it was the Coast Guard or them, and 3 someone there had -- I think it was from -- Port Richey had 4 told us to request.

5 MS. MCATEE: Was the Coast Guard on the scene at6 any time during the incident?

7 CHIEF GUDY: Yes, the Coast Guard was on the scene They had a little craft that they had 8 when I got there. 9 three guys on. They were just kind of on the -- I guess, 10 the northern end of where the channel makes a bend there. 11 They were sitting over there, actually, until I requested 12 them to come over and help us try to get our line back on 13 the boat, actually, just kind of sitting over there. They 14 said they couldn't come onto shore because the mud was 15 pretty deep between there and there.

16 UNIDENTIFIED SPEAKER: They also had a helicopter
17 on the scene, too.

18 CHIEF GUDY: And they did have a helicopter prior19 to my run.

20 MS. MCATEE: Do you know how they were notified of 21 the incident?

22 CHIEF GUDY: No idea.

MS. MCATEE: Do you ever do any training with theCoast Guard for marine accidents or response?

25 CHIEF GUDY: We -- the only actually training that

1 we actually do with them is, you know, when we have calls 2 with them, we've done quite a few along the edge of the 3 waters, most of the time there, you know, small motor craft 4 or medical emergencies coming in. 5 MS. MCATEE: You provide mutual aid for Port 6 Richey?

7 CHIEF GUDY: Yes, ma'am.

8 MS. MCATEE: Do you train with Port Richey? Do9 you do mutual aid drills? Things like that?

10 CHIEF GUDY: We do train with Port Richey. We 11 train with this engine out of this house here, Engine 19. 12 We also train with Engine 11 also, and their volunteers. 13 Engine 29 trains for them guite extensively.

MS. MCATEE: Does your fire department do any kind of marine training like, you know, marina response, things like that?

17 CHIEF GUDY: No, because we don't -- we do not really have -- I mean that's -- we have the Port of Hudson, 18 19 but that port is really in Port Richey, I mean, Port Richey 20 and we know that's the only, you know, area that actually 21 has, you know, activity of that nature where the commercial 22 vessels are going out with the (indiscernible). I guess 23 citizens are whatever you would call them, paid -- people 24 that pay --

25 UNIDENTIFIED SPEAKER: Customers.

1 CHIEF GUDY: Customers, yeah, for that. This is the first incident like this I've ever been on, you know, 2 I've never been involved with any -- most boat fires I've 3 4 had were sitting on a trailer. 5 MS. MCATEE: Yes. Or sitting on the edge of a lake. 6 CHIEF GUDY: 7 MS. MCATEE: Have you done a de-brief with the 8 responders yet? 9 CHIEF GUDY: We have not. 10 MS. MCATEE: Are you planning to do one? CHIEF GUDY: We hadn't really. I hadn't really 11 12 planned on doing one, because, I mean, it was just a -- I 13 mean, (indiscernible) kind of did the majority of the work out on the thing with his crews, and he's our most 14 experienced captain that we have on our shift, and 15 16 especially when it deals with water, he's, you know, grown 17 up around the water and knows a lot about it, and it showed 18 in his firefighting activity once I -- I mean, by the time I got there, they had the fire knocked down. 19 20 The smoke column was visible from Land O'Lakes 21 when I left, and by the time I got to -- into 22 (indiscernible), they (indiscernible) that - that was -- it

23 was hit. It already turned white. I mean by the time I got 24 there, it was pretty well much, you know, there just --25 probably some deep seeded fire that he pretty much had under

1 control.

MS. MCATEE: Anything else that you can think of that you'd like to add? CHIEF GUDY: No, just like I tell you, it was Port Richey's fire that was. They would do all the investigation (indiscernible). MS. MCATEE: Okay. (Whereupon, at 1:43 p.m., the interview was concluded.)
